### Gentlemen:

Per instructions from the Artesia office of the New Mexico Oil and Gas Commission, we are, by this letter, formally requesting your permission to co-mingle all production (gas and oil) from the hereinabove referenced wells. The production from each well will be metered by industry-accepted methods before co-mingling, and careful records will be maintained of such production.

This request is occasioned by first, our need to generate enough casing, head natural gas to justify the expense of installing a gas compressor in order to sell the gas into El Paso Natural Gas Company's 400+ pound line, and to have a sufficient quantity of gas to keep a compressor operating. Secondly, none of these wells make enough oil to support the cost of separators, heat treaters, and storage tanks, but co-mingled, they should do so.

As you may or may not be aware, the Bone Springs production in this area is not bountiful, however, there will be a significant amount of natural gas produced with accompanying oil production over a period of time if operators in the area can find less expensive ways to drill, complete, and produce the wells.

This request is one way in which we can hope to minimize our costs in the area, and is made possible by the prominity of the wells to each other and to a gas market.

Enclosed here within are:

- 1) Maps of the area with the acreage involed marked in yellow,
- 2) Copies of our well location and Acreage Dedication Plats filed with
- 3) A schematic drawing of our proposed metering, separation, storage facility, and compressor, all located on the Pad at the Giovengo #1 well with flow lines indicated coming from our Ray Howard #1 and Williams #1 wells.

We have written the land and mineral owners involved under the referenced wells in addition to the working interest owners and have in writing, their approval of the requested co-mingling.

We trust you will approve our request. Should you have further questions, or need information, please advise us and we shall make every effort to satisfy you.







Dear Mr. Ramsland:

This letter confirms our long distance telephone conversation of 18 February 1982, where I advised you that Mr. Giovengo had authorized me to instruct you that he would agree to the proposed commingling. It therefore will not be necessary for your field people to unhook the gas compressor from the Giovengo connection on the 22nd of February 1982.

Mr. Giovengo, as I explained, just wants to be sure that he gets all of the oil that is produced from his well. I feel that it will reassure Mr. Giovengo that the Oil Conservation Commission requires checking of the instrumentation and metering on the well every month to insure accuracy.

Mr. Giovengo is also concerned that the pumpers of the well are not doing as good as a job as they might do and by carbon copy of this letter I am advising Mr. Giovengo that there has been some information that the pumpers feel the Giovengos are tampering with the various valves on the well. Mr. Giovengo will be instructed by me that he and his family are not to go upon the properties, as not only are problems in the metering concerned, but there can be a danger to members of his family.

Lastly, as I stated to you in our telephone conversation, Mr. Giovengo has considered utilizing that portion of his contract to use gas from the well in his home. Though Mr. Giovengo has this right, I would discourage it, as I feel that since this gas would have to pass through regulators, there is a very very strong possibility that the risk involved would be much greater than any benefit gained by having free gas. I, of course, will be talking with Mr. Giovengo about all of these points, but wanted to confirm our telephone conversation. Thank you for your continued cooperation.
