

Gentlemen:

Getty Oil Company respectfully requests Approval to Commingle the Oil Production on its State "D" and State "E" Leases in accordance with Rule 309-B of the New Mexico Oil Conservation Commission Rules and Regulations.

In support of this Application, the following information is submitted:

- I. All production is from the Eunice-Monument Grayburg San Andres Pool.
- II. Working interest ownership and royalty ownership is common for these two leases.
- III. Attached is a plat showing the location of the wells and leases.
- IV. Attached is a schematic diagram of the proposed commingling facility located on Unit I, Section 16, T-21-S, R-36-E, Lea County, New Mexico.
- V. Production is to be allocated based on Monthly Well Tests run through a 3 phase meter separator.

There are 2 wells on each of these leases. The wells are Marginal Producers with the following production rate:

STATE "D"

Well No. 1 - 25 BOPD  
Well No. 2 - 5 BOPD

STATE "E"

Well No. 1 - 18 BOPD  
Well No. 2 - 3 BOPD

The production stock tank on the State "D" and State "E" must be replaced. In the interest of conservation and for continued economic operations of these leases, Getty Oil Company submits this request to commingle.




