In accordance with New Mexico Oil Conservation Commission Rule 309-B, Texaco Inc. respectfully requests permission to commingle liquid hydrocarbon production from the Vacuum Abo Reef pool from the New Mexico "R" (NCT-4) State Lease with that from the New Mexico "AE" (NCT-4) State Lease. Production from the "R" (NCT-4) State Lease will be metered prior to being transferred to the New Mexico "AE" (NCT-4) State Lease.

A plat of the subject leases indicating the well locations and a schematic diagram of the proposed commingling facility is attached.

All working interests and royalty interests are common throughout.

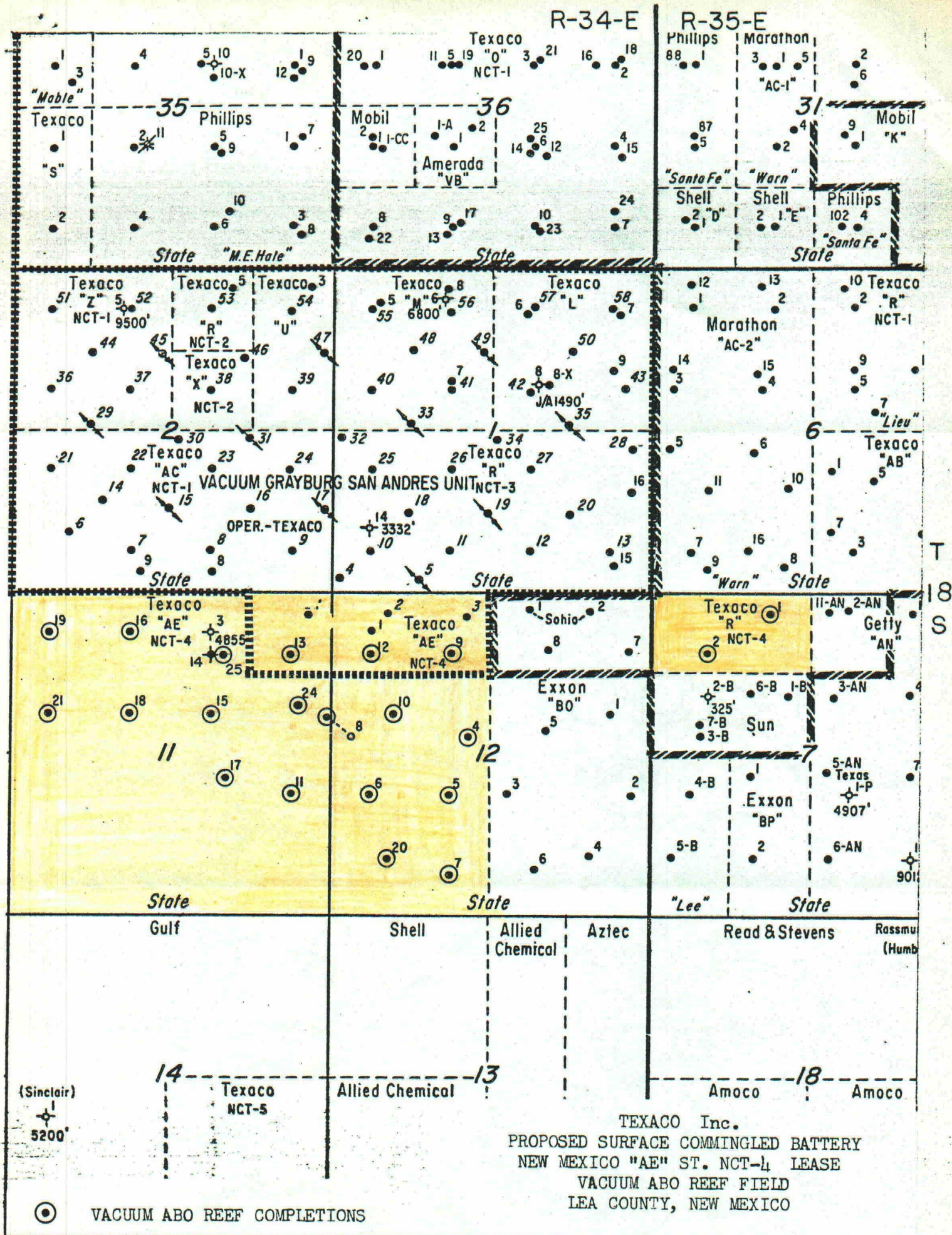

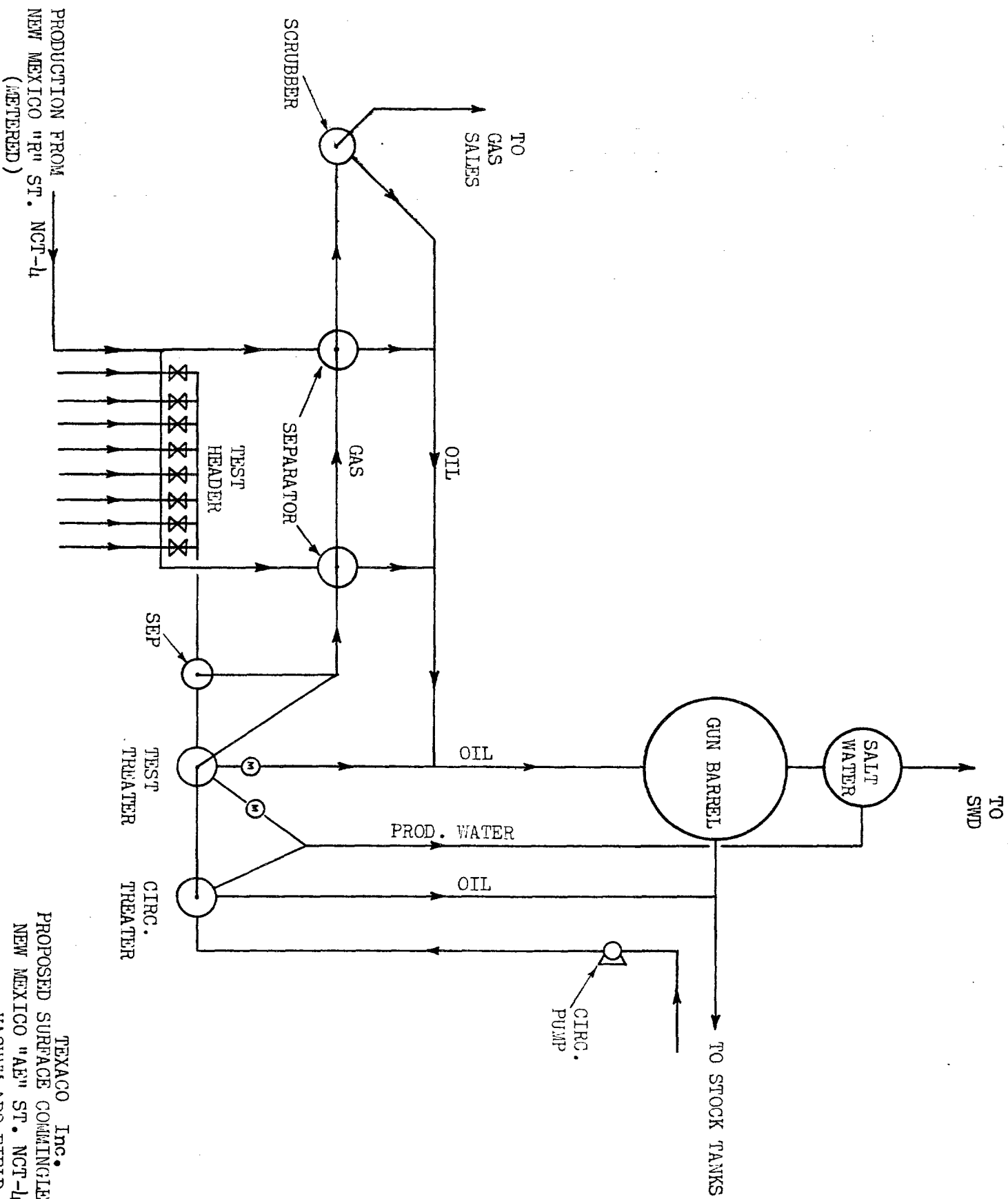

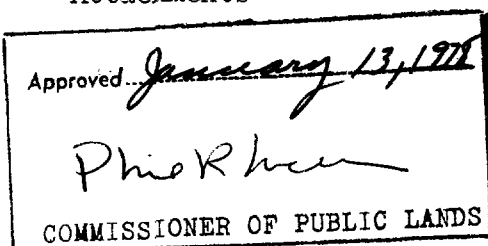
