
We have received a copy of the New Mexico Oil Conservation Division's Order #PLC-164 which notifies this office of your application to surface commingle the production from the above-captioned wells.

We are in receipt of your letter of March 29, 2000. Your letter requests our approval to surface commingle the gas production from three leases, transport to one lease, compress the gas in one compressor and sell through one central sales point.

It is our understanding that all gas from each well will be metered separately through orifice meters on lease prior to central compression at the Record lease.

Since it appears that all the New Mexico Oil Conservation Division's rules and regulations have been complied with, and there will be no loss of revenue to the State of New Mexico as a result of your proposed operation, your request is hereby approved. Our approval is subject to like approval by the New Mexico Oil Conservation Division.
