Reference is made to your application for administrative approval of an exception to Rule 309-A of the Commission Rules and Regulations to permit the commingling of Tres Papalotes Pennsylvanian production from your New Mexico (80), your New Mexico (86), and your New Mexico (87) leases in Section 33, Township 14 South, Range 34 East, Lea County, New Mexico, after separately metering the production from each lease.
