Gentlemen:

We request permission for off lease storage on our Harbold Lease, Seven Rivers production in the Empiro Field, Eddy County.

Until June 1st., effective date of the South Red Lake Grayburg Unit, this production was commingled with Grayburg, San Andres production into tank battery located in the NE/4 NE/4 Of Section 35-17-27. This tank battery remained in the unit and we erected 1-100 bbl. tank West of well No. 13, in the E $\frac{1}{4}$ of NW/4 of Section 35.

Since this production is very light (approximately 5 bbls daily), Continental Pipe Line Company will not make a connection at this location but will purchase the oil if we move tank to our lease in Section 26 where they have a connection.

Attached you will find plat showing our wells and proposed location of flow line and tank.

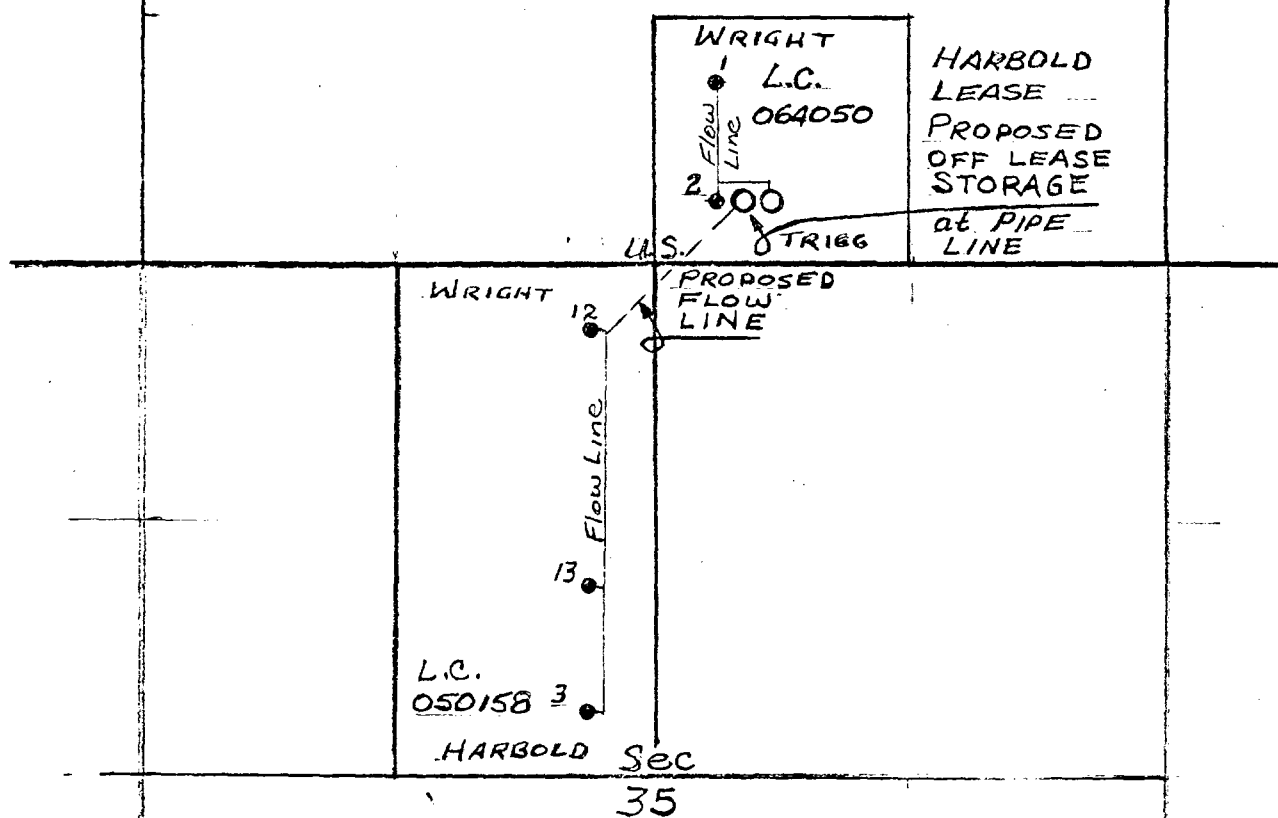
