The Western Oil Fields, Inc., respectfully requests that by Administrative Approval, the New Mexico Oil Conservation Commission, grant an exception to Rule 309-C for Off-Lease Storage.

Continental Pipeline Company has requested that in order for pipeline service to be sustained in the Turkey Track Field, Eddy County, New Mexico, that certain tanks for storage of oil be centralized in one location.

Western Oil Fields, Inc., proposes the following with approval:

1. To set a centralized tank battery located in NW/4 of NW/4, Section 15, Township 19S, Range 29E, Eddy County, New Mexico.
2. Separate tanks will be set for the following leases: State B-8096 (Western Oil Fields, Inc., Turkey Track No. 5 and No. 6 well); State E-2943 (Western Oil Fields Inc., Turkey Track No. 4 well); Lease No. E-701 (Western Oil Fields, Inc., Dickey Sullivan No. 1 and No. 2 wells); Lease B-8326 (Western Oil Fields, Inc., Samwell No. 1 well).
3. No commingling of production from any two leases will result, and separate flowlines and tankage will be installed.
4. There will be no intercommunication of the handling, separating, or storage facilities designated to each lease.
5. All parties owning an interest in the leases have been notified by registered mail this date.

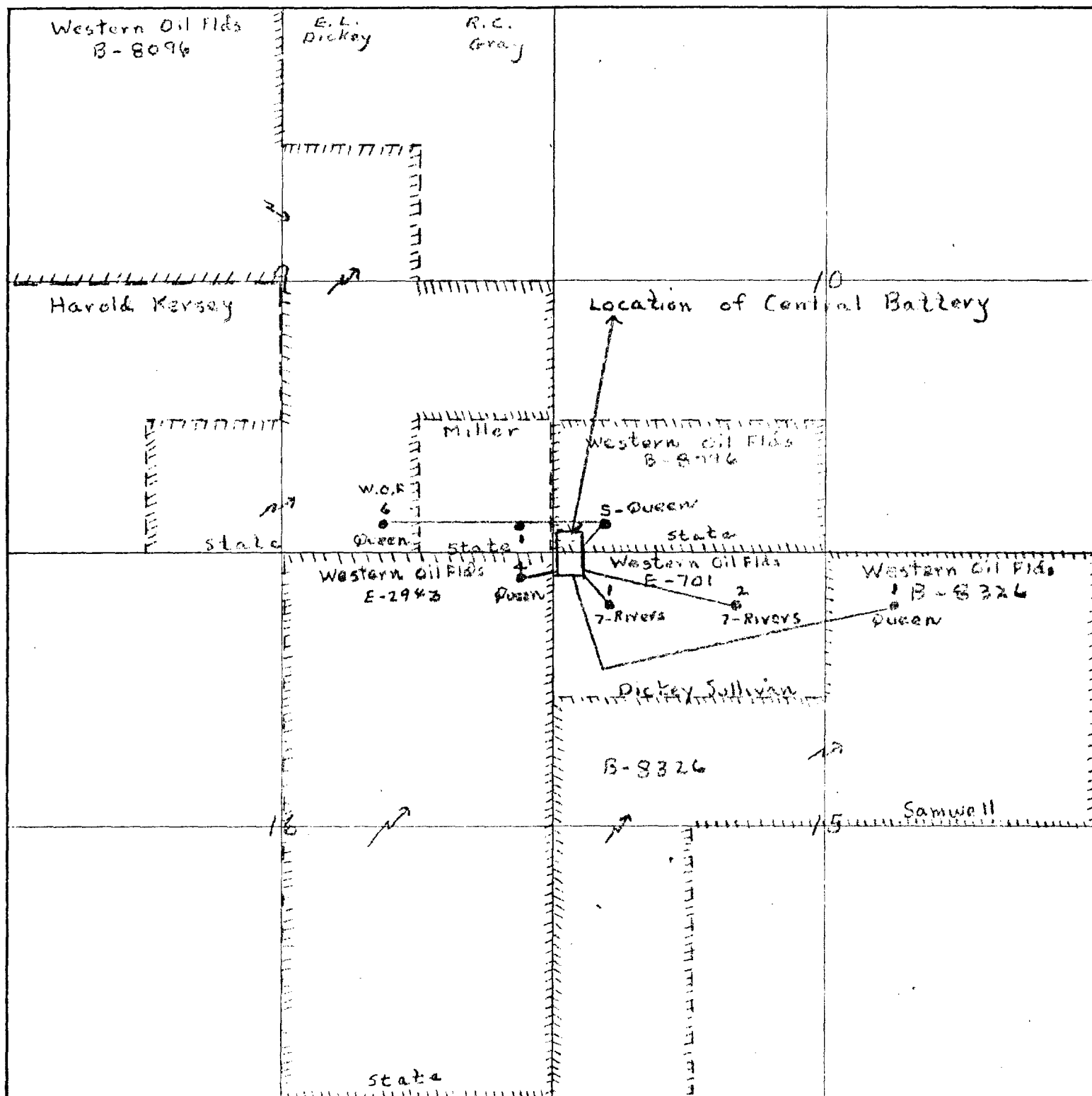
