Gentlemen:

As provided in Rule 309-C, Administrative Approval, Off-Lease Storage, of the Rules and Regulations of the New Mexico Oil Conservation Commission, an exception to Rule 309-A is hereby requested for Pennzoil Company's Federal Lease No. LC 02911, located in Section 33, T-17-S, R-33-E, Lea County, New Mexico. The Grayburg-San Andres Zone on this lease is under water-flood with Wells No. 2 and 3 on injection and Well No. 1 producing. The producer makes six barrels of oil and six barrels of water per day. The tank battery for this lease is located in the NE/4 of the NE/4 of Section 33. It is desired to establish a tank battery for this lease at the approximate center of Section 28. Federal Lease No. LC 02911 and our Phillips State Lease, No. B-2229-0 in Section 28 are served by a common water injection plant located at the center of Section 28. Also the tank battery for the Phillips State Lease is near the center of Section 28. Your approval of this request will enable us to consolidate all our major facilities for these leases at one location. This will facilitate the solution of several operating problems we face under the present arrangement such as more efficient use of field operating personnel, disposal of produced water, and more efficient use of the equipment on these leases.

We plan to accomplish this transfer of storage facilities by moving the Federal Lease treater to Section 28 and converting two of the four existing 436-barrel tanks at the Phillips State Lease battery to storage for the Federal Lease production. A flow line will be layed from the Federal Lease well to the treater inlet. There will be no mixing or commingling of the production from these two leases. There will be no intercommunication of the handling, separating, treating or storage facilities designated to each lease. All production from the Federal Lease will be from the Grayburg-San Andres Zone.

The attached plat shows the leases involved and the planned change in facilities.


The working interest ownership in these leases is the same for both leases and is shown below. Attached is the written consent of these parties for off-lease storage for the Federal Lease.

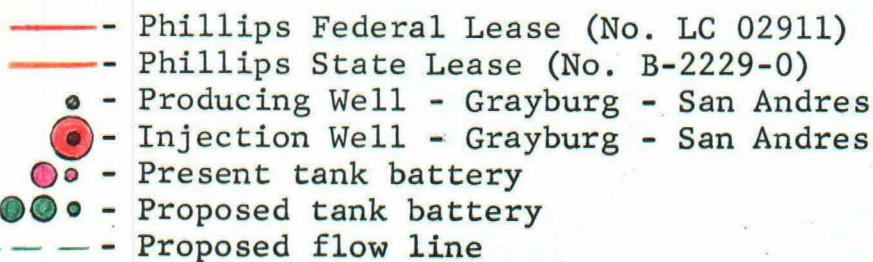


