**Gentlemen:**

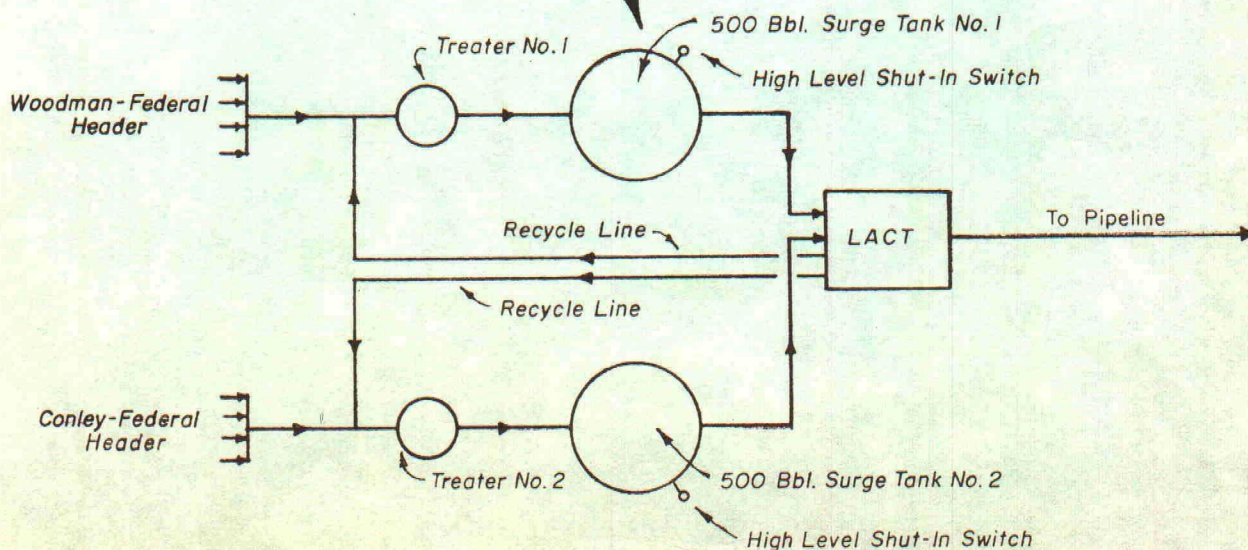
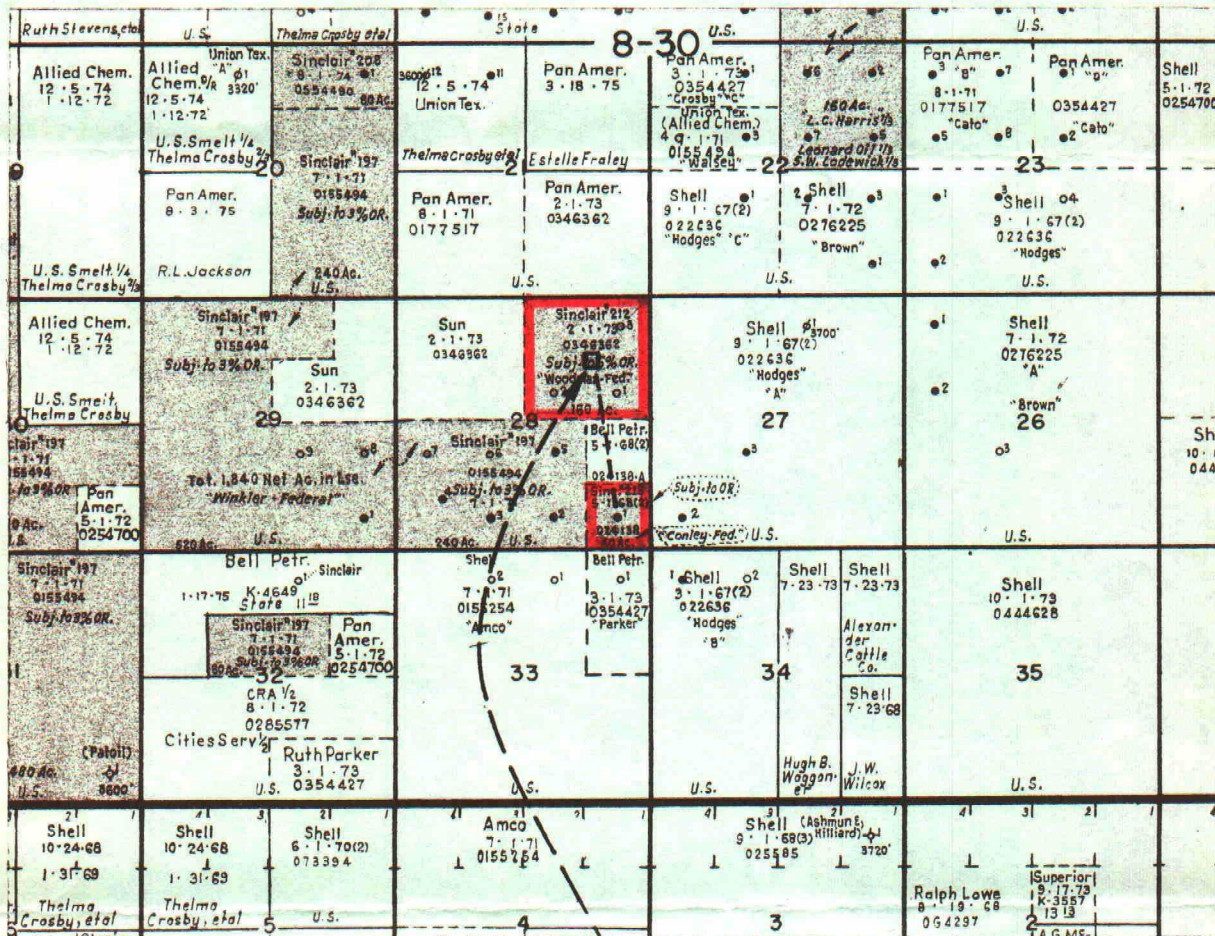


