Reference is made to your application dated April 28, 1969, for administrative approval of an exception to Rule 309-A of the Commission Rules and Regulations to permit off-lease storage for oil produced from your State "DM" Well No. 1, located in Unit P, Section 18, Township 13 South, Range 33 East, North Baum-Upper Pennsylvanian Pool, Lea County, New Mexico.

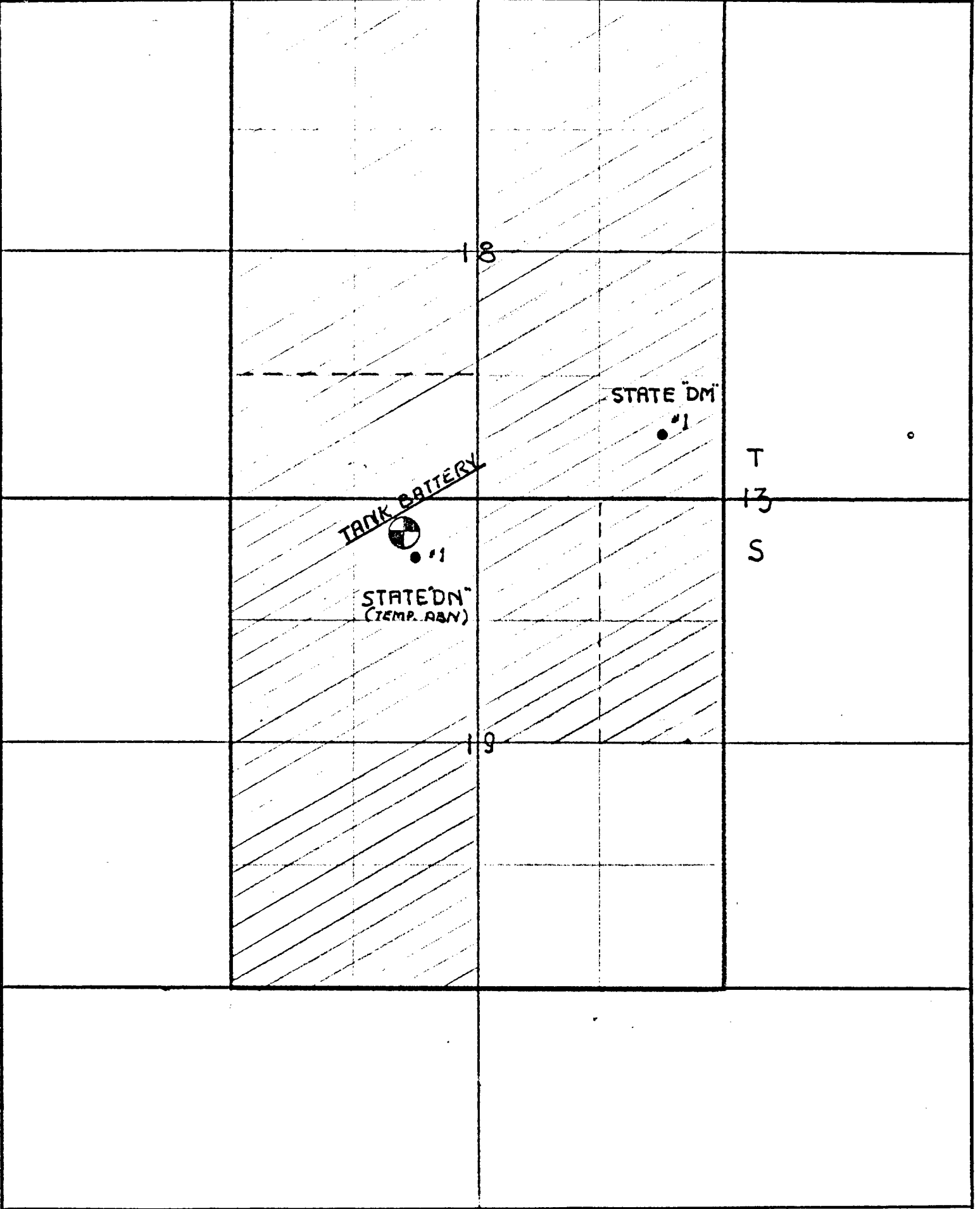
