Continental Oil Company has completed its Russell Federal 30 Well No. 2 in Unit D of Section 30, T-26S, R-32E in the North Mason Delaware Pool. We are currently drilling Well No. 3 in Unit E and expect to move immediately to No. 4 which will be located in Unit C of the same section.

We are in the process of designing a centralized tank battery and soon will submit an application for commingling of North Mason and Battleaxe Delaware production in that facility. As a temporary measure Continental Oil Company respectfully requests administrative approval to place tanks for North Mason Delaware oil production on the Thompson 19 Federal Lease, which is the site of the proposed centralized battery, for receiving Russell Federal 30 lease production. There will be no commingling of production from this lease with that from other leases until after approval of a commingling order. Continental Oil Company owns all of the working interest under this lease. Copies of this application are being furnished to the U.S.G.S. and the owners of the overriding royalty under the lease. A letter indicating the consent of the U.S.G.S. will be forwarded as soon as it is received.

It is respectfully requested that administrative approval of off-lease storage, under the provision of Rule 309 C be granted.


