
Union Oil Company of California



Union Oil Company of California requests administrative approval of an exception to Rule 303 to commingle production from the Anderson Ranch (Wolfcamp) Pool and an Undesignated (Devonian) Pool on the State "A" lease, Number E-8974, Lea County, New Mexico. Information pertinent to the commingling of this production follows:

- 1. Lease Description: 320 acres being; SW/4 of the SW/4, NW/4 of the SE/4, NW/4 of the NE/4 Section 33, and SE/4 of the SW/4, N/2 and SE/4 of the SE/4, NW/4 of the NW/4 Section 28, all in Township 15 South, Range 32 East. The working interest and the royalty interest are uniform under this lease.
- 2. Production To Be Commingled:

Pools: Anderson Ranch (Wolf Allowable (Noy.): 129 BOPD Gravity at 60 F: 36 Value per barrel: \$ 2.93 Value per day: \$377.97	
Total Commingled Production (Nov.): Estimated Gravity of	401 BOPD

Prices based on intermediate crude posting of \$3.01 per barrel offered by purchasers in the Field.

3. Producing Wells: State "A" 1-33 is located 330 feet from the south and west lines, Section 33, T-15-S, R-32-E, Lea County, New Mexico. This well has developed commercial production

from the Anderson Ranch (Wolfcamp) Field and an Undesignated (Devonian) Pool. Dual completion of this well is planned. An extension to the Anderson Ranch (Devonian) Field will be requested. A map showing the lease and well locations is enclosed.

4. Lease Storage: Storage will consist of four 500 barrel tanks. A metering separator will be installed on production from each pool from each well. A schematic drawing of the installation is enclosed. Custody transfer is planned should the lease be connected to Gulf Refining Company's pipe line system as requested.


SCHEMATIC OF TANK INSTALLATION


