Reference is made to your letter dated March 28, 1966, wherein you request an amendment to Administrative Order PC-67 which authorized the commingling of Paddock and Penrose-Skelly production on your V. M. Henderson Lease located in the N/2 of Section 30, Township 21 South, Range 37 East, Lea County, New Mexico, after separately metering the production from the Paddock Pool and determining the Penrose-Skelly production by means of the subtraction method.

It is our understanding that all of the production on this lease is now of marginal nature and that you wish to commingle said production without separate measurement, allocating the production to each of the pools on the basis of periodic well tests.

Administrative Order PC-67 is hereby amended to delete the metering requirement, provided however, that you shall notify the Commission if any well in either of the aforesaid pools becomes capable of top allowable production.
