Reference is made to your application dated March 1, 1962, as amended, for administrative approval of an exception to Rule 303 (a) of the Commission Rules and Regulations to permit the commingling of the Ellenburger, Waddell, McKee, Fusselman, Drinkard and Blinebry production from your State "EM" Lease, comprising the E/2 SE/4 of Section 2, Township 25 South, Range 37 East, North Justis Field, Lea County, New Mexico, after separately metering the production from each zone.

By the authority vested in me under the provisions of Rule 303 (b) of the Commission Rules and Regulations, you are hereby authorized to commingle the production from the Ellenburger, Waddell, McKee, Fusselman, Drinkard and Blinebry zones in the North Justis Field on the above-described State "EM" Lease, after separately metering the production from each zone, provided however, that the installation shall be operated in accordance with the provisions of the Commission "Manual for the Installation and Operation of Commingling Facilities."
