> Amendment Administrative Order PC-69

Gentlemen:

Reference is made to your letter of August 25, 1964, wherein you request that Administrative Order PC-69, as amended January 17, 1964, be further amended. The original order authorized the commingling of Ellenburger, Waddell, McKee, Fusselman, Drinkard, and Blinebry production on your New Mexico State "DM" Lease after separately metering the production from each pool. The amendment of January 17, 1964, authorized the commingling of Ellenburger, Fusselman, and McKee production after separately metering the Fusselman and determining the Ellenburger and McKee production by means of the subtraction method. It is our understanding that Ellenburger, McKee, and Fusselman production on this lease are now all of marginal nature and that you wish therefore to discontinue separately metering the Fusselman and determining the production from each of the three pools by means of periodic well tests.

Administrative Order FG-69 is hereby amended to permit the aforesaid commingling in the above-described manner, provided however, that the installation shall continue to be operated in accordance with the provisions of the Commission "Manual for the Installation and Operation of Commingling Facilities," and provided further, that you shall notify the Commission at such time as any well in any of the aforesaid pool is capable of top allowable production.
