Re: APPLICATION OF CONTINENTAL OIL CO.
FOR AMENDMENT OF ADMINISTRATIVE ORDER
PC-101 TO PERMIT COMMINGLING OF UN-
DESIGNATED ABO PRODUCTION WITH NORTH
JUSTIS TUBB-DRINKARD AND DEVONIAN
POOLS ON ITS STATE A-2 LEASE, LOCATED
IN SECTION 2, T25S, R37E, LEA COUNTY,
NEW MEXICO

Your approval was granted October 4, 1962, under N.M.O.C.C. Administrative Order PC-101, to permit the commingling of the production from the Tubb-Drinkard, Devonian and Fusselman Pools, North Justis Field, on Continental Oil Company's State A-2 Lease comprising the W/2 SE/4 of Section 2, T25S, R37E, Lea County, New Mexico, after separately metering the production from each pool.

Upon testing, prior to completion of the well, the North Justis Fusselman Pool was found to be commercially non-productive. Subsequently, the well was completed as a Tubb-Drinkard, Devonian and Undesignated Abo triple completion. The Abo crude has been analyzed and classified as sweet, as is the production from the Tubb-Drinkard and Devonian.


It is therefore requested that Administrative Order PC-101 be amended to permit the commingling of liquid production from the Undesignated Abo Pool with the North Justis Tubb-Drinkard and Devonian Pools on the State A-2 Lease, after separately metering the production from each pool. The exhibits previously submitted are applicable upon the substitution of the "Abo formation" where the "Fusselman formation" now appears.

Your amended approval will be sincerely appreciated.

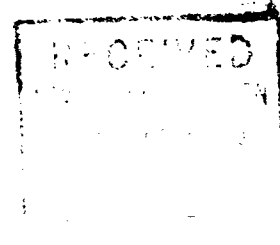
