Dear Sir:

Humble Oil & Refining Company respectfully requests administrative approval to commingle oil production from the Blinebry Oil Pool and Drinkard Oil Pool on its F. F. Hardison "B" Lease, located in Sections 27 and 34, Township 21 South, Range 37 East, Lea County, New Mexico.

All Drinkard wells on this lease are marginal. Drinkard oil averages 38° API gravity, classed as intermediate sweet, with a posted price of \$2.97 per barrel. The Blinebry oil from recently recompleted F. F. Hardison "B" No. 2 has a gravity of 38.6° API, classed as intermediate sweet, with a posted price of \$2.97 per barrel. There will be no monetary gain or loss due to commingling. The Blinebry oil will be provided with metering and sampling facilities prior to commingling with the Drinkard oil at F. F. Hardison "B" Battery No. 1.



We have your letter of November 26, 1962, stating your desire to commingle crude oil obtained from well No. 2 in the Blinebry Field with crude oil currently being produced from wells No. 1, 7 and 8 in the Drinkard Field on the captioned property, and requesting our approval as the purchaser of said commingled crude oil.

Texaco Inc., is currently purchasing the Drinkard Field production obtained from the captioned property and is agreeable to purchasing the commingled production obtained from the two fields mentioned above under said property. Settlement with Humble will continue to be made under the terms of Texaco's 100% division order, without tax deductions, based on Texaco's posted price for New Mexico (intermediate sweet) crude oil, now \$3.01 for 40°-449° gravity.

The Texas-New Mexico Pipe Line Company advises they are prepared to run the subject commingled production for account of Texaco Inc., upon receipt of the New Mexico Conservation Commission's approval.

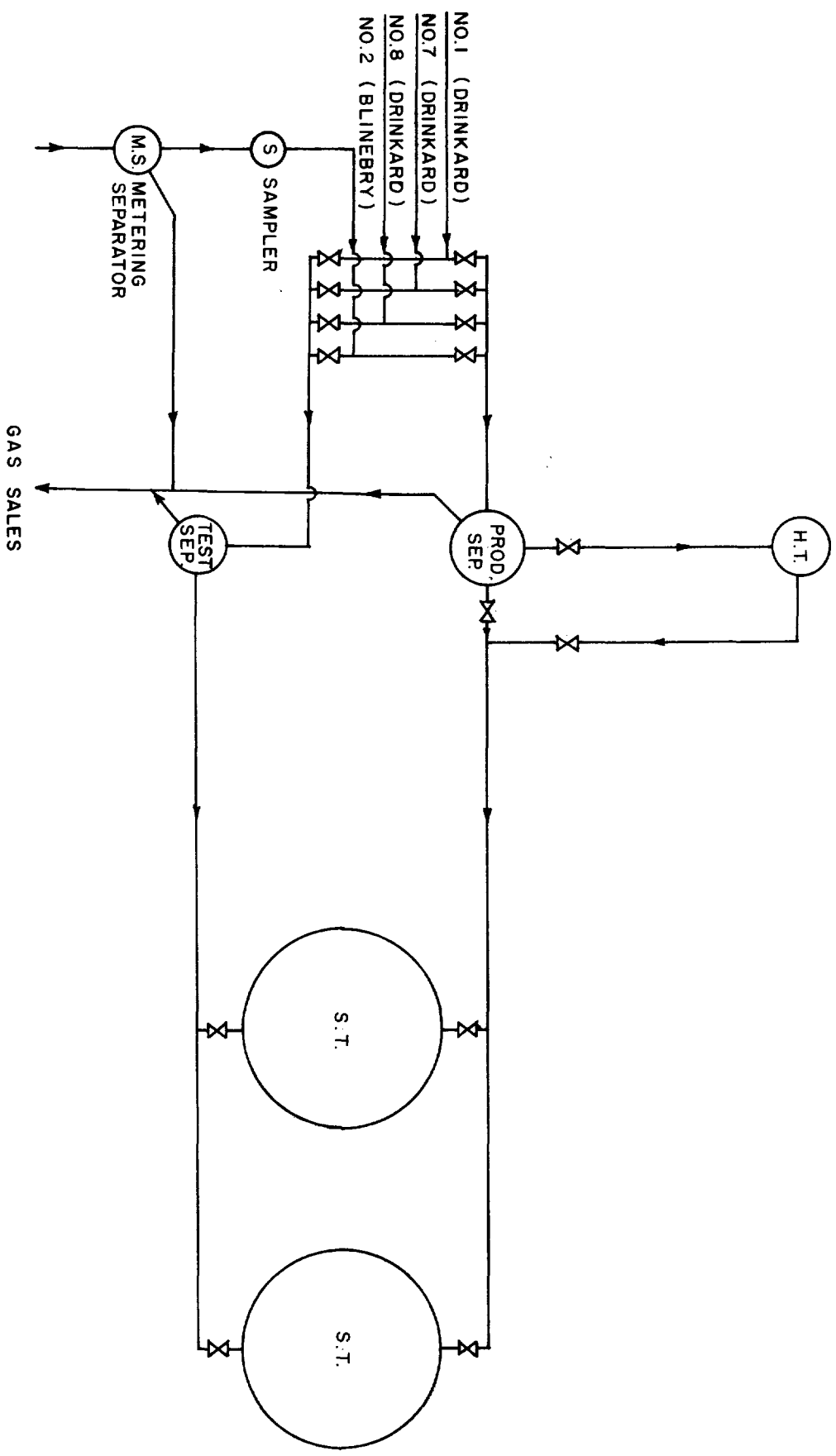

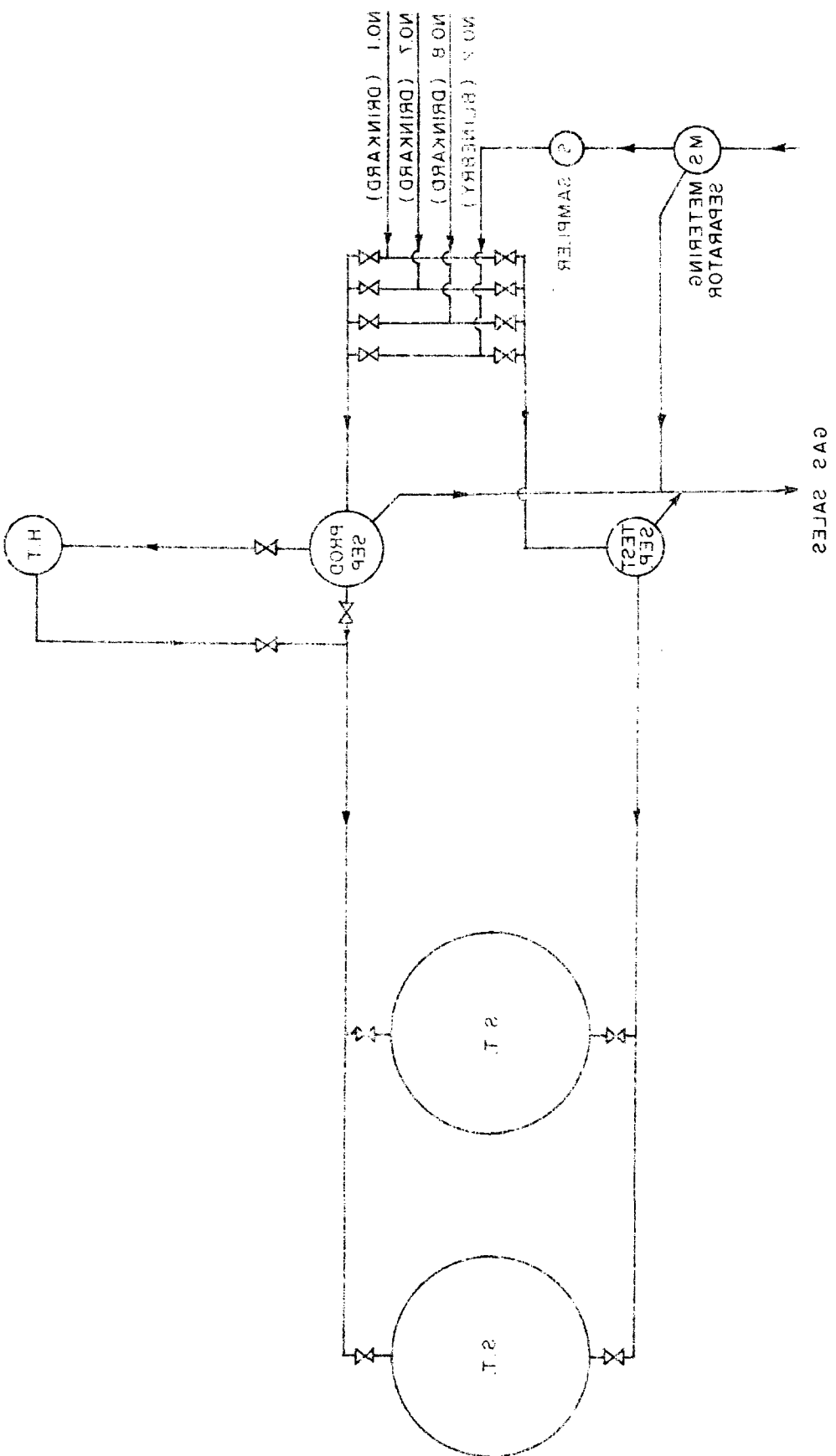

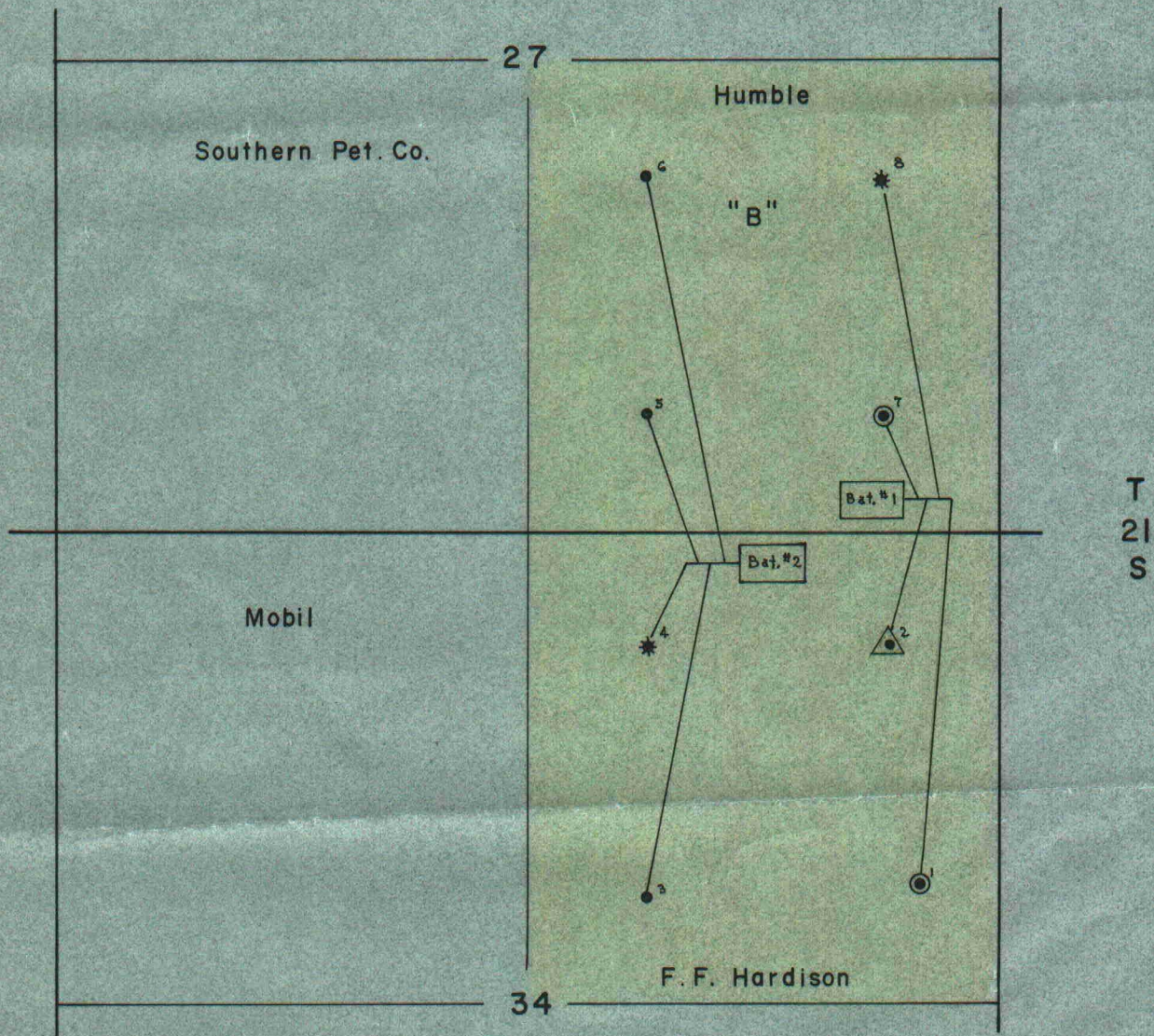
DRINKARD PORTION OF TANK BATTERY NO. 1
