Sun Oil Company hereby requests exception to Rule 303(A) for permission to commingle marginal oil production from the Oil Center Blinebry and the Eunice pools on our J. A. Akens lease located in Section 3, T-21-S, R-36-E, Lea County, New Mexico.

On June 10, 1963 Sun Oil Company obtained permission to commingle production from the Oil Center Blinebry and the Eunice pools with metering facilities using the subtraction method for oil allocation, Administrative Order PC-144. We hereby ask that this order be amended as per the above request.

At the present time all wells are marginal and thus, we propose to allocate production back to each well on the basis of monthly tests.

The Akens lease is a 100% Sun Oil Company interest lease with common royalty ownership. Gravity of the lease oil from both pools is 40° API and sells for an average of \$3.20 per barrel. Because of the previous commingled storage there will be no change in the gravity or the price of the oil.


A schematic diagram of the present and proposed facilities, a lease plat, and well tests are attached.






