Gentlemen:

Administrative Order PC-199 granted Continental Oil Company authority to commingle production on our Baish A Lease, Sections 21 and 22, T-17S, R-32E, Lea County, New Mexico from the Baish Wolfcamp, Baish Yates and Maljamar Abo pools, provided production from two of the three pools be metered. At the time Administrative Order PC-199 was granted some of the wells in each of the pools on the Baish A Lease were top allowable. The attached tabulation of production from the Baish A Lease shows none of the wells are top allowable and the tests listed indicate they are not capable of producing top allowable. Therefore, Continental Oil Company respectfully requests that Administrative Order PC-199 be amended to eliminate the necessity of metering production from the individual pools on the Baish A Lease. Production will be allocated to each pool and well based on current Gas-Oil Ratio Surveys
