of Production from Pools.

Dear Sir:

The Western Oil Fields, Inc., respectfully requests that the Oil Conservation Commission grant administrative approval to commingle the oil production from the Gulf Bunin No. 1 well completed in the Wantz Abo Pool with the oil production from the Gulf Bunin No. 2, 3, and 4 wells completed in the Terry Blinbry Pool.

The two pools underly a single basic lease and have identical ownership.

Our application requests that Western Oil Fields, Inc. be allowed to commingle in a single marketing facility.

The four wells involved are all of marginal status.

Attached please find diagrammatic sketch of the lease showing location of wells, tank battery and pool from which each well produces.

Also, attached, is a tabulation of the gravities, the values and the volumes of the liquid hydrocarbons from each pool.

The actual value of the commingled production will not be less than the sum of the values of the production from each common source of supply.
