Gentlemen:

Getty Oil Company requests Administrative Approval to commingle oil production from the Hobbs Grayburg-San Andres and Drinkard Pools on its W. D. Grimes Lease in accordance with New Mexico Oil Conservation Commission Rule 303 (b), 2-B.

In support of this application, the following information is attached:

1. Table I - Gravity and Sales Value Data for the Crude Production.
2. A schematic diagram of the proposed commingling facilities.
3. A plat of the W. D. Grimes Lease showing the location of the wells and pools from which each well is producing.

In addition, the following information is submitted:

1. Royalty and working interest ownership is common for all pools.
2. It is proposed to meter the Drinkard oil production using a National Net Oil Computer.
3. The Grayburg-San Andres oil production is to be determined by the Subtraction Method as outlined in the New Mexico Oil Commission "Manual for the Installation and Operation of Commingling Facilities".
4. The 80 acre Grimes Lease is completely developed with two (2) Grayburg-San Andres and one (1) Drinkard wells.

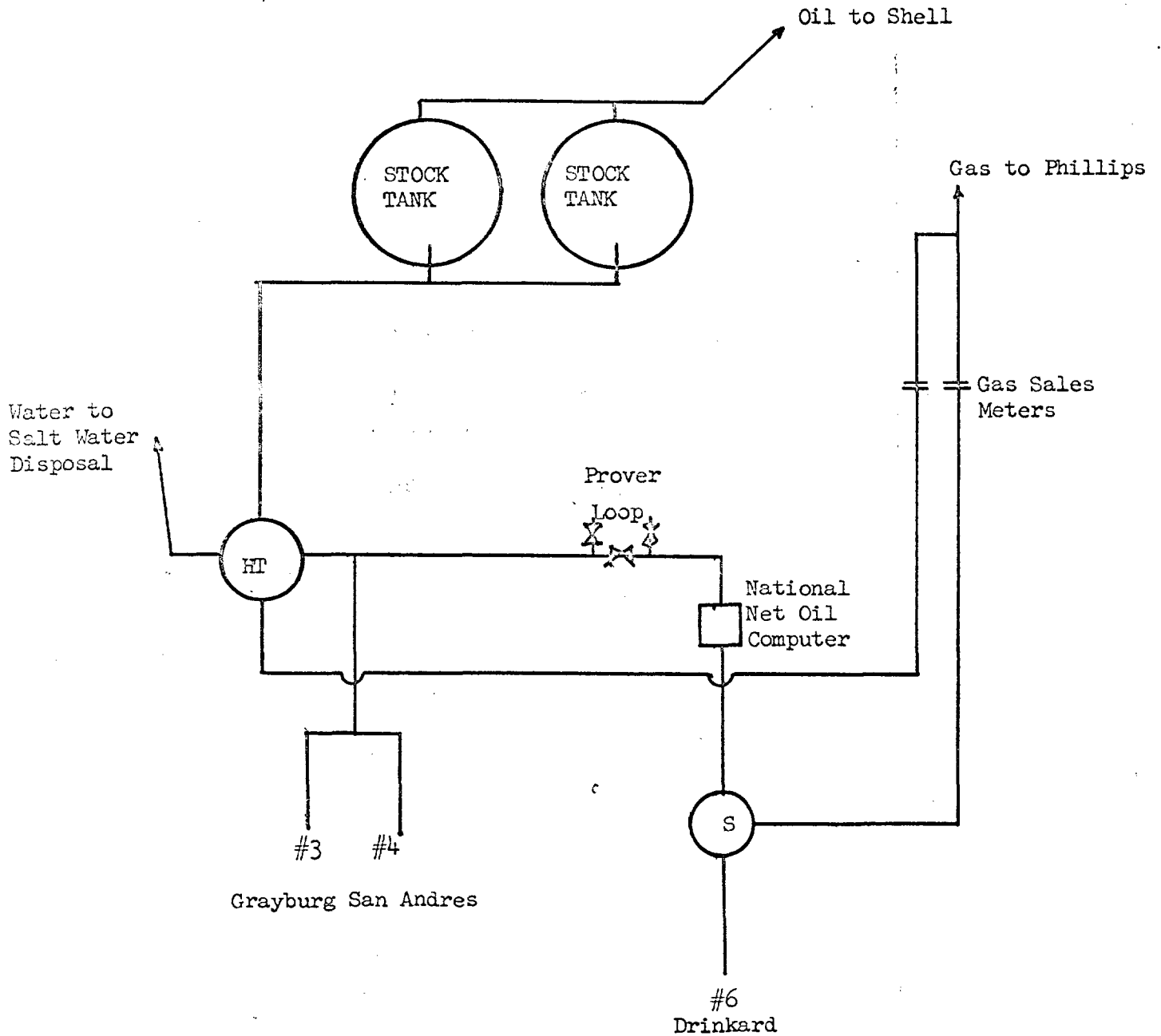

FLOW DIAGRAM OF PROPOSED COMMINGLING FACILITIES

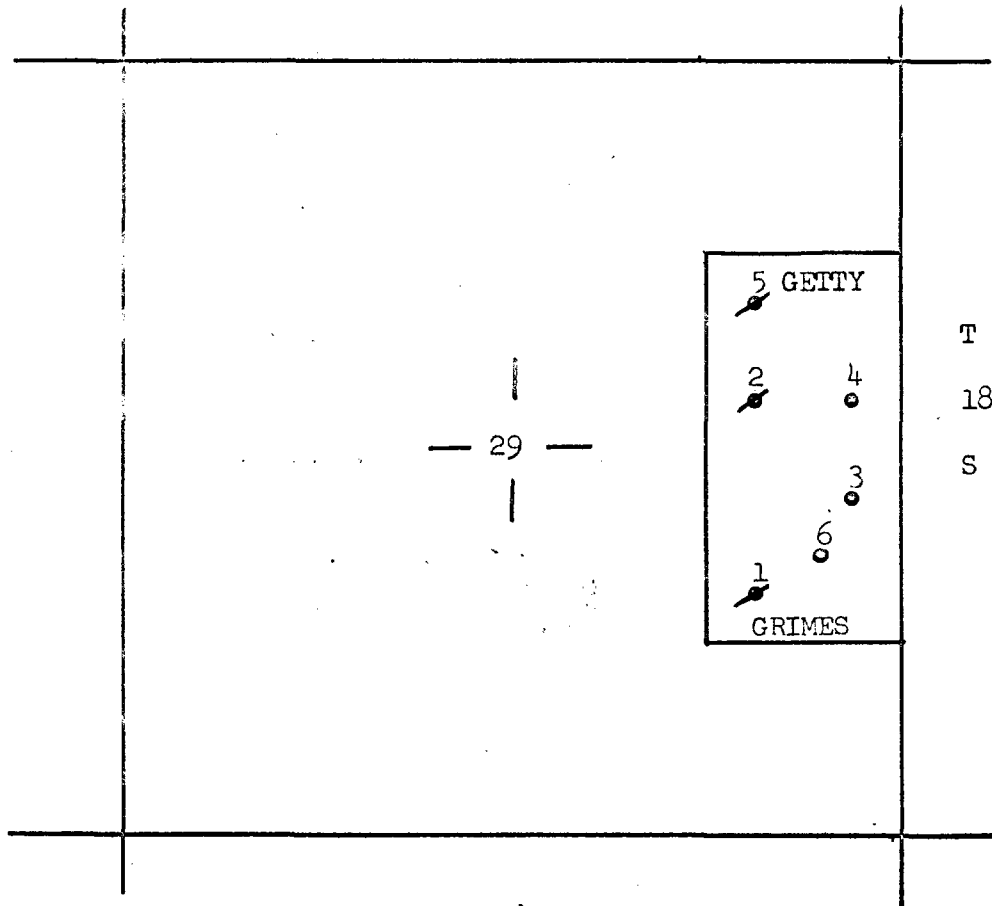
