Gentlemen:

Reference is made to your application dated January 14, 1971, for administrative approval of an exception to Rule 303-A of the Commission Rules and Regulations to permit the commingling of Penrose-Skelly and Drinkard production on your W. W. Weatherly Lease in Section 17, Township 21 South, Range 37 East, Lea County, New Mexico, after separately metering the Penrose-Skelly production and determining the Drinkard production by means of the subtraction method.

By the authority vested in me under the provisions of Rule 303-B of the Commission Rules and Regulations, you are hereby authorized to commingle the production from the aforesaid pools on said lease in the above-described manner, provided however, that the installation shall be operated in accordance with the provisions of the Commission "Manual for the Installation and Operation of Commingling Facilities," including the requirement for non-reset counters on the meters. Please notify the Hobbs District Office of the Commission at such time as the installation is complete in order that an inspection may be made thereof.

It is the responsibility of the producer to notify the transporter of the aforesaid commingling authority.
