As allowed by Commingling Order PC-450, commingling of production from all wells in the Fren-Seven Rivers and Grayburg-Jackson Pools of the Skelly Unit was completed as of September 1, 1973.

Commingling facilities consists of two separate tank batteries, and two separate LACT Systems in Township 17 South, Range 31 East, Eddy County.

LACT System No. 1 is located in Unit Letter A, Section 22, and will serve the following wells:

Fren-Seven Rivers Pool - Producing Well No. 2

Grayburg-Jackson Pool - Producing Wells No. 17, 18, 20, 23, 25, 27, 28, 29, 31, 33, 35, 36, 37, 39, 41, 43, 45, 47, 49, 50, 51, 53, 55, 57, 106, 108, 109, and 111.

Injection Wells No. 19, 21, 22, 24, 26, 30, 32, 34, 38, 40, 42, 44, 46, 48, 52, 54, 56, and 58.

LACT System No. 2 is located in Unit Letter H, Section 28, and will serve the following wells.

Fren-Seven Rivers Pool - Producing Wells No. 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, and 16.

Grayburg-Jackson Pool - Producing Wells No. 11, 59, 60, 61, 62, 63, 65, 67, 68, 70, 72, 74, 76, 78, 80, 82, 84, 86, 88, 90, 92, 94, 97, 99, and 107.

Injection Wells No. 64, 66, 69, 71, 73, 75, 77, 79, 81, 83, 85, 87, 89, 91, 93, 95, 96, 98, and 100.

Tank Battery No. 5 is located in Unit Letter D, Section 22, and will serve the following wells:

Fren-Seven Rivers Pool - Producing Well No. 3

Grayburg-Jackson Pool - Producing Well No. 101.

Injection Well No. 3.

Tank Battery No. 6 is located in Unit Letter B, Section 14, and will serve the following wells;

Fren-Seven Rivers Pool - Producing Well No. 114.

Grayburg-Jackson Pool - Producing Wells No. 103, 104, 110, 112, and 113.

Injection Wells No. 102, 105 and 114.
