Gentlemen:

Please accept this letter as Mesa's application for permission to commingle the condensate liquids from the subject well as required by Rule #53 "Rules and Regulations Concerning the Sale, Lease and Other Disposition of State Trust Lands."

The above well was dually completed in the Blanco Mesaverde and Pictured Cliffs formations underlying commonly-owned leases more fully described on the attached list. We make this request due to the low condensate yields from the Pictured Cliffs formation expected at 0.7 barrels per MMCF as compared to the Mesaverde yields expected at 2 barrels per MMCF. Economically the Pictured Cliffs formation condensate does not justify a separate storage tank, but would produce additional revenues if stored and sold with Mesaverde condensate.

An economic analysis will not be applicable for the State royalty as the condensate from both formations are of the same gravity.

The commingling operation is a simple one being accomplished entirely on the surface; therefore, we request that the attached schematic diagram be accepted in lieu of a description of the operating sequence as required by Paragraph 8 of the above mentioned rules.






