

RE: Application requesting administrative approval for an exception to Rule 303; State "AF" Lease, Sec. 8, T18 S, R35 E, Lea County, New Mexico

Gentlemen:

Penroc Oil Corporation as operator of the captioned lease requests an administrative approval to commingle oil production at a common tank battery.

State "AF" well No. 1 is recently completed in the Mid Vacuum Devonian and is being tested. Initial rates are 600 BOPD, 220 MCFD and 2400 BWPD. Prior to bringing No. 1 well on production, the lease has been producing from the Abo zone in well No. 2. Well No. 2 averages 8 BOPD, 9 BWPD and 10 MCFD as evident from the production curve (attached). Currently well No. 2 is shut-in awaiting approval of this application, in order for Penroc to produce both wells in a common tank battery.

All wells on the State "AF" lease have common royalty interest (12.5% for the State of New Mexico) and have common working interest owners. The surface facilities include: A heater treater, test separator, free water knock out and a header system plus storage tanks. Well No. 2 will be tested through the test separator which has a non-reset metering device. The production for well No. 1 will be determined by taking the difference between total production and well test on No. 2.

An early approval from your office will be greatly appreciated. If you have any questions, please contact the undersigned. Thank you in advance for your cooperation.


