Amerada Hess Corporation respectfully requests your attention concerning an exception to Rule 303-A, to surface commingle production from the Caprock Devonian and Wolfcamp pools on the State EC "C" Lease, Sec. 11, T-12S, R-32E, in Lea County.

The State EC "C" #1 is presently a Devonian completion producing 65 BOPD, 2499 BWPD, and 1 MCFPD. The State EC "C" #2 was recently recompleted from the Devonian to the Wolfcamp pool, and produces 48 BOPD, 12 BWPD, and 86 MCFPD. The oil production from the Devonian and Wolfcamp pools is classified as intermediate crude, with API gravities of 43.5 ° and 42.4 °, respectively. Current crude oil pricing information indicates that there is no price adjustment from 40° to 45° API gravity, for oil with an intermediate classification. As a result, the value of the commingled product will be equal to the sum of the individual product values. Since neither well is capable of top allowable production, all production could be commingled in the heater treater, with proper production allocation to each pool accomplished by monthly well testing. Amerada Hess will notify the State immediately in the event that either well becomes capable of top allowable production.

I have included a plat map of the State EC "C" Lease, depicting the completion of each well and a schematic of the battery facillity. In addition, since State Lands are involved, a copy of this request has been forwarded to Mr. William R. Humphries, State Land Commissioner.




