Gentlemen:

Cities Service Oil Company proposes to commingle oil production from certain wells in the Corbin area located in Section 32-T17S-R33E, Lea County, New Mexico. It is requested that administrative exceptions be granted to Rules 303(a) and 309-A.

Production is from eight single completion wells on five leases as shown on the attached plat. The three production zones are Maljamar Grayburg-San Andres, Corbin Queen and Corbin Abo. Oil production from each lease and zone will be kept separate until metered and sampled in compliance with state rules. The proposed treating and metering facilities as shown on the attached schematic will be located on State "CB" Lease and connected into the IACT unit which currently serves State "CB" #2.

The volumes of oil from each pool, based on April, 1966, production, are as follows:

Maljamar Grayburg-San Andres	82.70 bbls. per day
Corbin Queen	8.40 bbls. per day
Corbin Abo	<u>65.60 bbls. per day</u>
Total	156.70 bbls. per day.

Gravities and values of the crude from the various wells which is currently stored and sold separately are shown in the following tabulation:



The expected gravity of the commingled crude is calculated at 38.0 degrees API which will yield \$452.86 daily at \$2.89 per barrel. This represents a daily revenue increase of \$1.96 by crude commingling.

The royalty beneficiary on all leases is The State of New Mexico; however, a diversity exists on each of the leases for overriding royalty. A copy of this application with all attachments have been forwarded by certified mail to all parties owning and/or representing overriding royalty interests and to the crude oil and gas purchasers. Approval for this commingling facility has been granted by the Commissioner of Public Lands, State of New Mexico. A copy of the approval is attached.

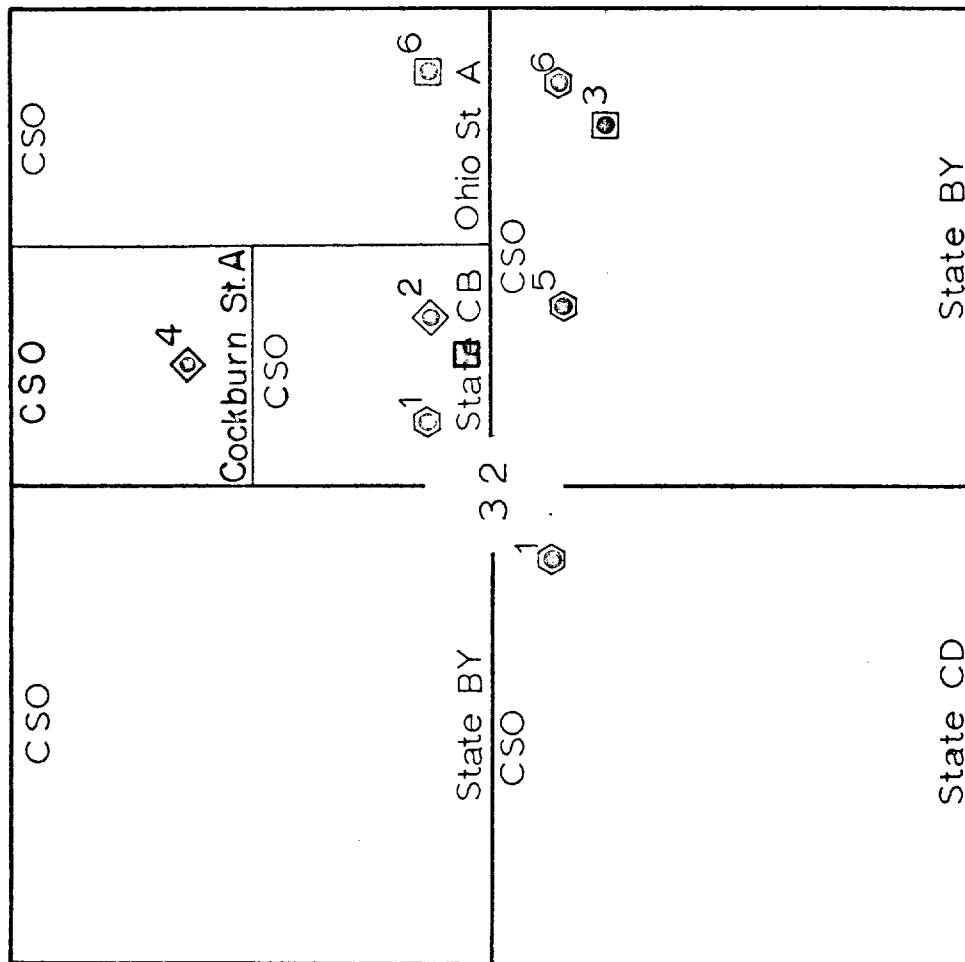

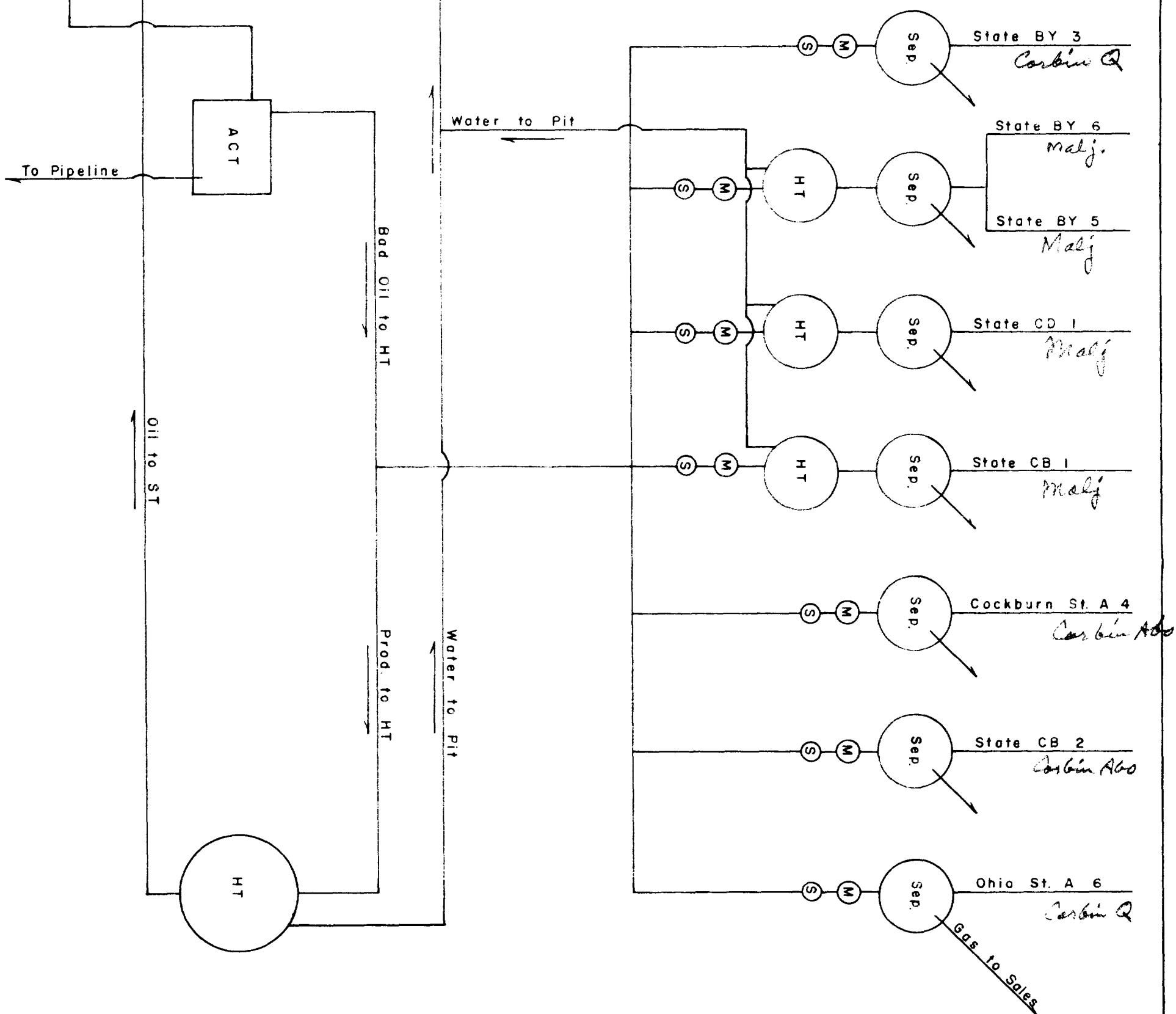

Proposed Commingling Facilities



We have received your letter of April 7, 1966, requesting permission to withdraw your application dated January 4, 1966, regarding your proposal to commingle oil production from certain wells in the Maljamar Grayburg, Corbin Queen and Corbin Abo pools. These wells are specifically located in the E/2 and NE/4 SW/4 of Section 32, Township 17 South, Range 33 East. It is our understanding that you propose to alter the installation as indicated in your schematic diagram which accompanied your letter of April 7, 1966.

This proposal satisfactorily fulfills our requirements for commingling. Accordingly, the Commissioner of Public Lands hereby alters the approval issued on January 12, 1966, and in place thereof, approves your proposal of April 7, 1966.

The Commissioner hereby reserves the right to amend or withdraw the approval at his discretion if it becomes contra to the best interests of the State of New Mexico.

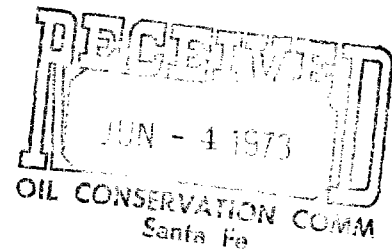
