Dear Mr. Porter:

Carter Foundation Production Company requests an exception to Rule 303-A, under authority of Rule 303-B, to permit surface commingling of hydrocarbon production from wells on the E. C. Hill "D" Federal Lease in the Teague Devonian Pool, and the E. C. Hill "M" Federal Lease in the Teague Simpson Pool, located in Sections 34 and 35, Township 23 South, Range 37 East, Lea County, New Mexico.

Following are the detailed data as required by Rule 303-B in making application for administrative approval to commingle the production from two common sources of supply with identical ownership:

(1) Gravity of Teague Devonian oil: 39.6 degrees API.
 Gravity of Teague Simpson oil: 46.0 degrees API.

(2) The Teague Devonian oil price - \$3.54 per barrel;
 150 barrels per month valued at \$531.00.
 The Teague Simpson oil price - \$3.56 per barrel;
 2,500 barrels per month valued at \$8,900.00.
 Total value of 2,650 barrels - \$9,431.00.

(3) Anticipated gravity of the commingled Devonian and Simpson oil is 45.6 degrees API, priced at \$3.56 per barrel; the expected total value of 2,650 barrels is \$9,434.00.

(4) Attached is schematic diagram of the proposed installation according to the provisions of the Commission's "Manual for the Installation and Operation of Commingling Facilities" dated October 1, 1969.

(5) Enclosed is plat showing the applicant's Teague Devonian and Teague Simpson wells on the E. C. Hill Federal Lease.


(6) The actual commercial value of the commingled production is approximately \$3.00 per month more than the sum of the values of the production from each common source of supply.

(7) Attached is copy of our letter dated February 29 to the Regional Supervisor of the United States Geological Survey, Roswell, New Mexico, requesting approval of the proposed commingling.

(8) Included is tabulation of the daily production for the past sixty days showing that the average daily production of the applicant's Teague Devonian and Teague Simpson wells is below the top allowable for both pools (per Commission's Manual, Section II, paragraph 1. Marginal Zones, page 5). Therefore, crude commingling is permitted without separately measuring the production from each pool.

Carter Foundation Production Company respectfully requests administrative approval, without notice and hearing, to permit the commingling of the Teague Devonian and Teague Simpson produced hydrocarbons on the E. C. Hill Federal Lease, Lea County, New Mexico.



Gentlemen:

Carter Foundation Production Company desires to produce the Hill "D" Lease (Devonian) and the Hill "M" Lease (McKee) into a common tank battery.

The monthly oil production from the four McKee wells approximates 2,500 barrels of 46° gravity oil, and the two Devonian wells less than 200 barrels of 39° gravity oil. Commingling this production would result in a 45° gravity mixture and, therefore, a price increase of two cents per barrel for the Devonian oil. A small amount of gas is sold from the McKee wells, and no gas is sold from the Devonian wells. These two zones underlie the same Federal Lease No. 064118, and the ownership in the produced hydrocarbons is identical.

Carter Foundation Production Company is preparing an application to commingle this production to the New Mexico Oil Conservation Commission, and the consent of your office is required. If you have no objection to commingling the Teague (Devonian) and Teague (Simpson) production on the E. C. Hill "D" and "M" Federal Lease No. 064118, would you please advise this office.
