The above-named company is hereby authorized to commingle Blinebry, Tubb, Drinkard and Eumont Pool production from the following leases:

LEASE NAME: H.T. Mattern (NCT-D) Lease
DESCRIPTION: SE/4 SW/4 Section 6; NW/4 Section 7, T- 22 South, R-37 East NMPM;


LEASE NAME: H.T. Mattern (NCT-E) Lease
DESCRIPTION: E/2 NE/4, SW/4 NW/4 Section 12, T-22 South, R-37 East, NMPM

Production shall be allocated to each lease by separately metering the production from each lease prior to commingling.

NOTE: This installation shall be installed and operated in accordance with the applicable provisions of Rule 309-B of the Division Rules and Regulations and the Division "Manual for the Installation and Operation of Commingling Facilities." It is the responsibility of the producer to notify the transporter of this commingling authority.

REMARKS: All wells on each respective lease with common ownership may be allocated production on the basis of well tests. Each well with diverse royalty interest shall be individually metered prior to commingling.

Gentlemen:

Chevron U.S.A. Inc. respectfully requests that Commingling Order PLC-53, dated January 12, 1979, be ammended to include the H.T. Mattern (NCT-E) # 15 located in Section 12, T-22-S, R-36-E in Lea County, New Mexico. The H.T. Mattern (NCT-E) # 15 is a new well completion producing from the Eumont Oil Pool.

The H.T. Mattern (NCT-D & E) Battery currently receives DHC production, NMOCD Order R-7238 - 3/28/83 and DHC-547 - 01/20/85, from the Drinkard Oil, Tubb Oil and Gas, and Blinebry Oil and Gas Pools.

In order to save the considerable expense of installing and maintaining new production facilities for the H.T. Mattern (NCT-E) # 15, it is desired to commingle this production into the existing H.T. Mattern (NCT-D & E) Battery located in Sec 7, T22S, R37E.

In completion of the surface commingling of production from the subject leases, it should be noted that provisions will continue to be incorporated to allow for individual well testing and proper allocation of production for each pool. Also, royalty interest owners have been notified of this application by certified mail, royalty interests within each pool underlying the two leases will be maintained and the purchaser will accept the commingled production. Attached is a tabulation showing individual pool gravities, production and revenues along with the expected commingled values. Also attached are battery schematics, a brief production history of each well, and a lease plat.
