Dear Jim:

Per our telephone conversation of May 14, 1981, Harlan Oil Company respectfully requests that they be allowed to co-mingle production from the two above described leases.

Production on the two wells, the Featherstone Federal # 1 (330 FNL & 990 FWL) and the Featherstone-Welch # 1 (1650 FNL & 990 FWL), have been averaging together 4-6 barrels per day. The gravity of the two wells is similar.

Ownership under both wells is identical as follows:

Harlan Oil Company	.4125	W.I.

Harlan Oil Company, as operator of these two wells, needs to rebuild two tank batteries that presently exist, one on each lease. Due to deterioration of the tanks and the poor condition of flowlines we would like to replace this equipment. However, due to the low productions runs on these leases it would be uneconomical to rebuild two separate facilities when one will suffice. We therefore, respectfully request that we be allowed to build one tank battery for oil runs on both leases.

The Featherstone Federal # 1 was completed as a Queen/Grayburg well producing from 1773 to 1785 feet. The Featherstone Welch # 1 was completed as a Queen well producing from 1693 to 1713 feet.

We would appreciate your early decision on this inquiry as repairs are needed.




