Reference is made to an exchange of correspondence beginning with our copies of applications to the New Mexico Energy and Minerals Department, Oil Conservation Division dated February 12, 1982 mailed to you on behalf of our client David Fasken soliciting your approval of his planned surface facilities and his proposed off-lease storage plan. The correspondence ended with your two letters of February 18, 1982.

As to your letter regarding the off-lease storage provision for the Devonian production, we are including the \$10.00 filing fee and herewith re-submitting the application for your approval.

As to your letter disapproving our request to comingle production from acreage within the same state lease No. E-8563, we are herewith re-submitting this application for your consideration with certain additional stipulations and modifications which we trust will meet the requirements of your regulation.

- (1) The production from each separate tract within State Lease No. E-8563 dedicated to different State of New Mexico institutions will be metered prior to storage in a common tank.
- (2) The crude oil purchaser, P & O Falco, Inc., will issue a separate division order for each tract and separate checks for the metered runs from each tract.
- (3) All metering will be pursuant to equipment specifications and procedures approved by the NME & MD, OCD (see attached).
- (4) The casinghead gas from each tract will be metered separately before being comingled and the purchaser, Phillips Petroleum Co., will issue separate checks for the gas from each tract (currently the casinghead gas from the Devonian is too small to meter).
- (5) The crude oil purchaser, P & O Falco, Inc., in consideration for the one pipe line connection will pay the sweet crude posted price for all production (currently the Strawn is paid

for at the intermediate crude posting. Currently this will result in a \$0.30 per bbl increase in the value of the Strawn crude oil).

The purpose of these requests is to eliminate the duplication of surface equipment with an estimated savings of \$90,000 to the working interest owners.


