LEASE NAME: Leamex Lease  
DESCRIPTION: S/2, S/2 NW/4 of Section 25;

LEASE NAME: Philmex Lease  
DESCRIPTION: E/2 NW/4, SE/4 SW/4 of Section 26, NW/4 NE/4, S/2 NE/4, SE/4 NW/4 of Section 35 and the N/2 NW/4 of Section 36;

LEASE NAME: State "F" TG Lease  
DESCRIPTION: S/2 NW/4, N/2 NE/4 and the SE/4 NE/4 of Section 36; and,

LEASE NAME: State "E" TG Lease  
DESCRIPTION: SW/4 NE/4 of Section 36,

All in Township 17 South, Range 33 East, NMPM, Lea County, New Mexico

Production shall be allocated to each lease by well tests. (If this method or the subtraction method is to be authorized, all commingled production must be of identical ownership including working interest, royalty interest, and overriding royalty interest.)


FURTHER: The operator shall notify the Hobbs District Office of the Division upon implementation of the commingling process.
