Texakoma Oil and Gas Corporation hereby requests approval for a non-standard location for its Amoco #1R well to be located 1693' FNL 397' FEL of section 21, Township 30 North, Range 12 West, in the Flora Vista Fruitland (Sand) Pool, San Juan County for geological reasons.

The proposed well is to replace the Amoco #1 well which is located 810' FNL 880' FEL of section 21. The intent is to get as far as possible from the original well without creating a hazardous situation. The distance between wells proposed here is 1006 feet.

A standard location in the west-half of the northeast quarter would fall in the watershed of Farmington Lake and pose a possible contamination situation. Topography prevents the well being located farther south or southwest.

It is believed that the drilling of the subject well will be in the best interest of conservation and the prevention of waste.

All offset operators or owners as shown on the enclosed exhibit were notified of this application by Certified Mail at the same time as the mailing of this application.
