Texakoma Oil & Gas Corporation hereby requests approval for an off-pattern location for its La Plata 16 #1 well, API No. 30-045-30786, to be located 682 feet from the north line and 1297 feet from the west line of section 16, Township 31 North, Range 13 West, in the Basin Fruitland Coal Gas Pool (71629), San Juan County, New Mexico because of geology.

The location is near the western edge of the productive area of the Fruitland Coal formation and considered a marginal economic venture.

Exhibit A shows ridge lines highlighted in yellow of the more competent sandstone beds within the Kirtland/Fruitland Shale formations due to the settling of the San Juan Basin and/or the uplift of Ute Dome. The outcrop of the Basal Fruitland Coal formation is in Range 14 West.

Exhibit B shows all the wells of record in the Basin Fruitland Coal Gas Pool in Townships 31 and 32 North, Ranges 13 and 14 West. There are no Fruitland Coal wells in the southwestern quarter of Township 31 North, Range 13 West; the northwestern half of Township 32 North, Range 13 West; or in Range 14 West of this exhibit.

Exhibit C is a plat which shows the operators of the offset leases.

Exhibit D is a list of offset operators names and addresses notified of this application by Certified Mail at the same mailing as this application.

Exhibit E is a copy of Form C-102, Well Location and Acreage Dedication Plat.

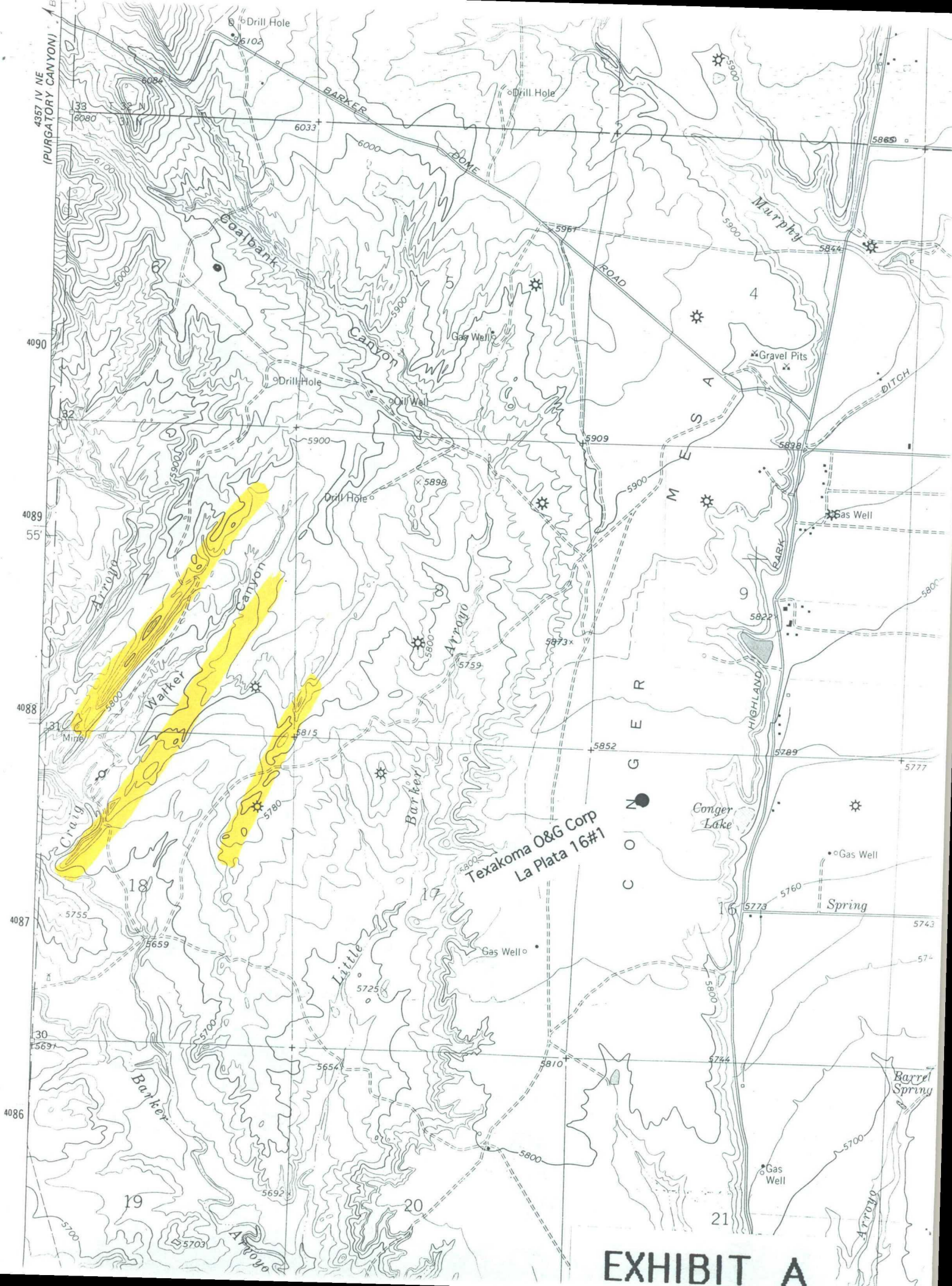

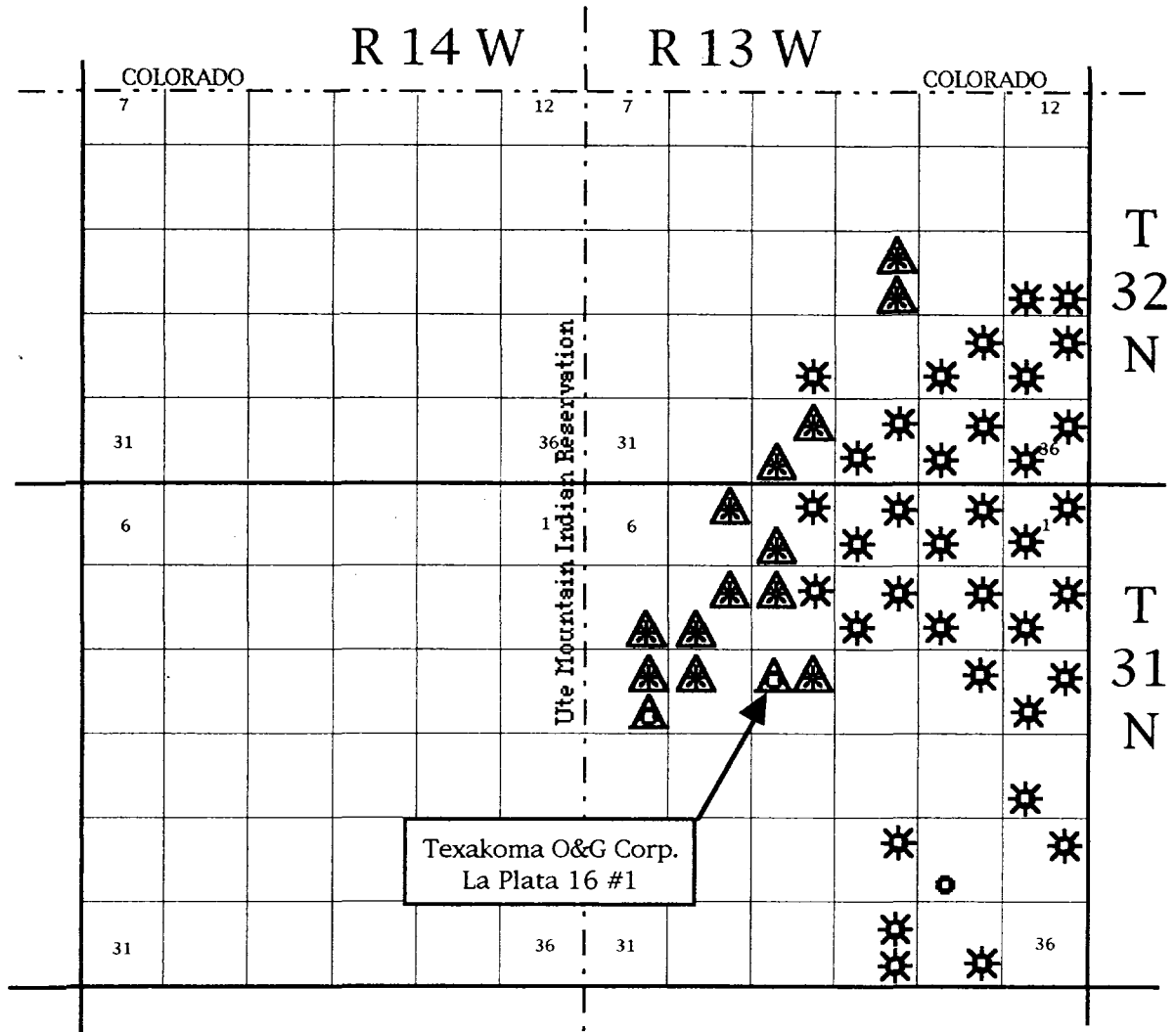

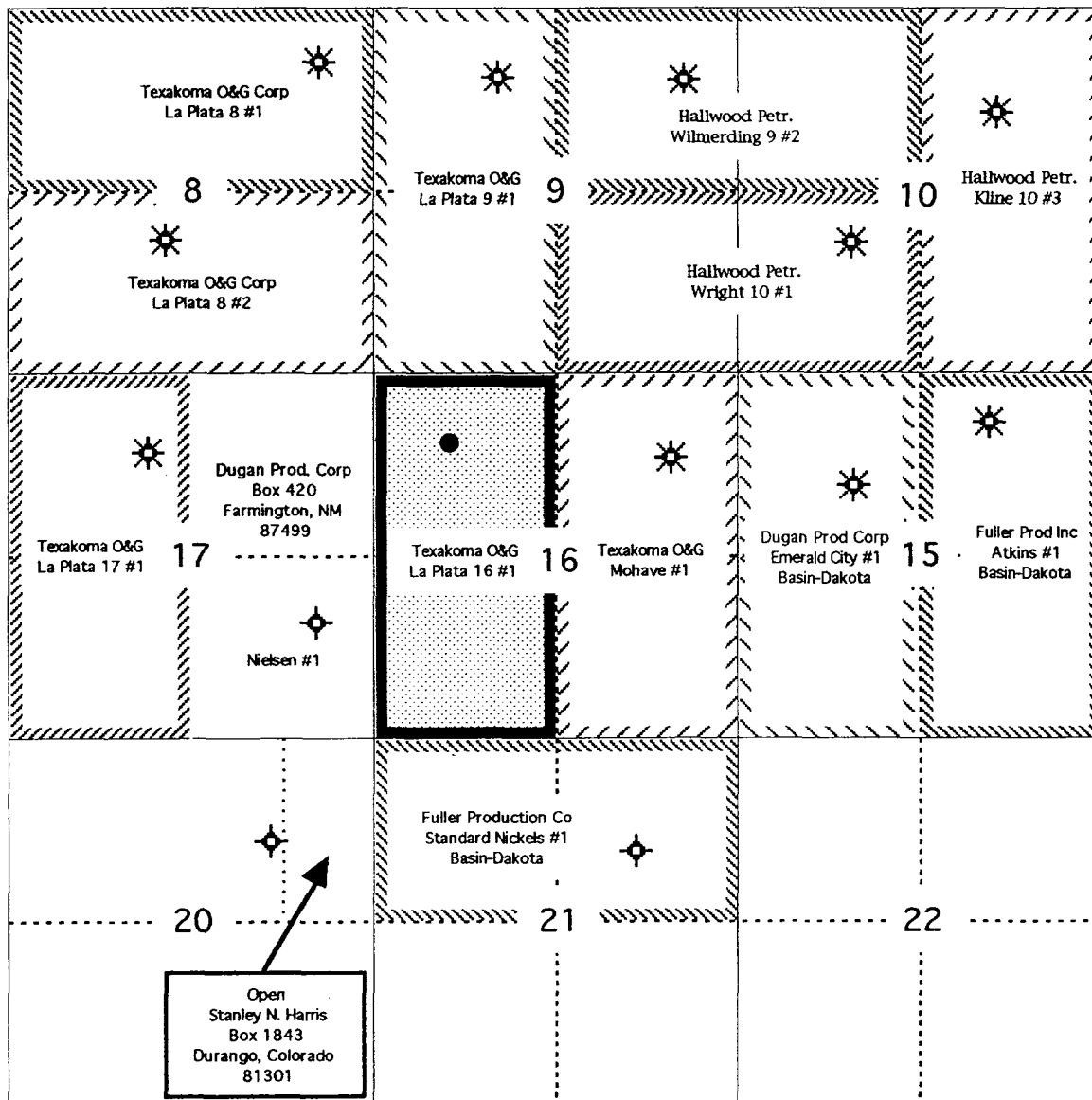


Fruitland Coal Wells

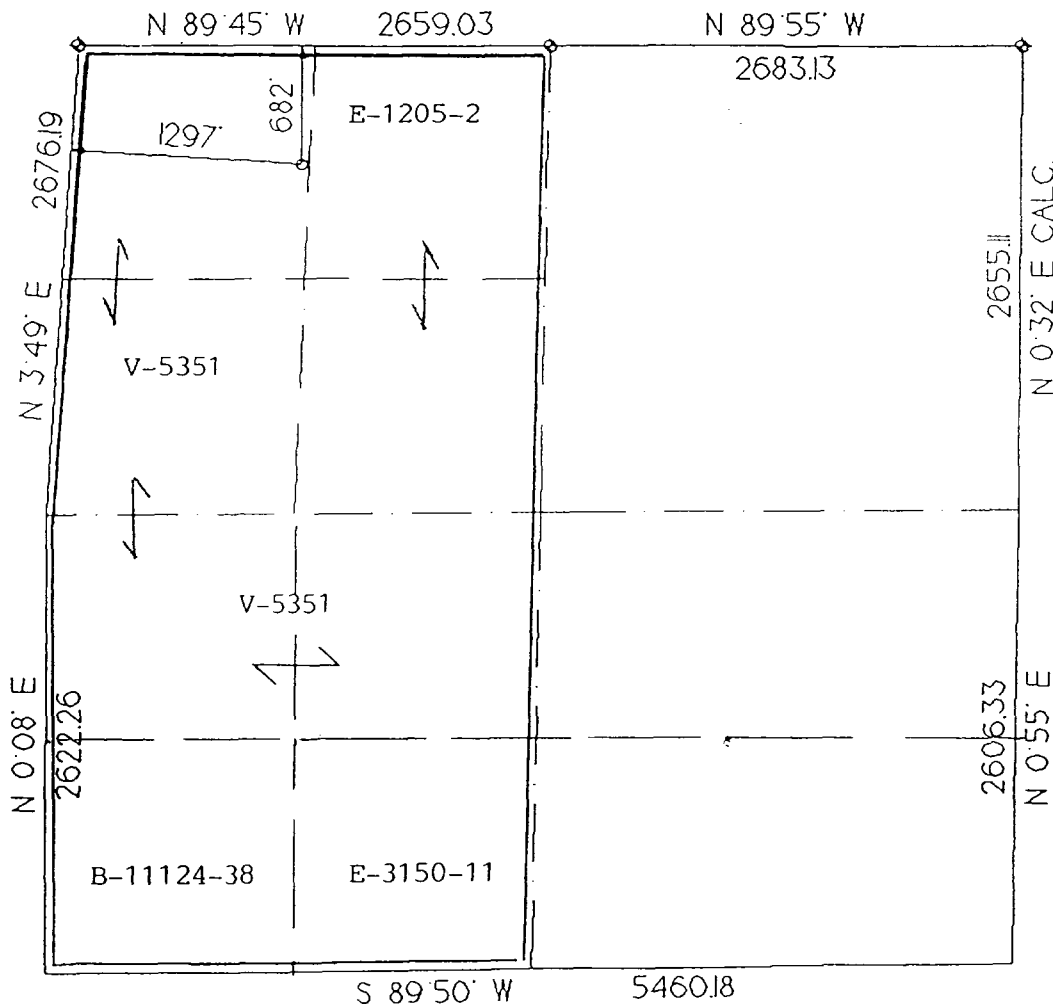
