

This letter acknowledges: (i) my e-mail message to you on Thursday, January 24, 2002 (see copy attached); and (ii) your administrative application dated December 4, 2001 for an unorthodox deep gas well location for the above described well. The Division received this application on January 22, 2002, and assigned it NMOCD application reference No. *pKRV0-202435463*. Please refer to this number in future correspondence with the Division.

Our preliminary review indicates that the information provided in the application is not sufficient to process an administrative order at this time. It appears that your application may be incomplete with respect to notice. It was stated in this application that Yates is the **leaseholder** of state Leases No. VA-2482 and VA-2473.
