Pursuant to Division Rule 104.F.(2), Pogo Producing Company applies for administrative approval of an unorthodox gas well location for the following well:

The well will be drilled to test the Morrow formation (McMillan-Morrow Gas Pool). Under Order No. R-2917, as amended, the pool is spaced on 640 acres, with one well allowed per quarter section, and wells to be no closer than 660 feet to a quarter section line. A non-standard unit comprising the S½ of Section 7 was approved by Division Order No. R-11308. A Form C-102 is attached as Exhibit A. The existing Davis "7" Well No. 1, located in the SW4SW4 of Section 7, is a Morrow producer.

The application is based on geologic reasons. Attached as Exhibit B is an isopach of the Morrow "Singer" Sand, which is the producing Morrow zone in this area. Attached as Exhibit C is a statement of geologic reasons why the unorthodox location is necessary. The proposed location will minimize risk and increase the chances of obtaining a commercial well.

Attached as Exhibit D is a land plat of the area. The S½ of Section 7 and all of Section 18 are fee land in which royalty, overriding royalty, and working interest ownership are common. Thus, the unorthodox location does not adversely affect anyone, and notice has not been given to any offset interest owner.







Geologic Reasons for Unorthodox Location

- 1. The Middle Morrow "Singer" Sand is the productive zone in the McMillan Morrow Gas Field.
- 2. The attached exhibit shows an Isopach of the gross sand thickness for the Morrow "Singer" Sand, in colorfilled contours. Thick black contours show the elevation on the top of the "Singer" Sand.
- 3. The structural configuration shows regional dip to the southeast.
- 4. The "Singer" Sand averages 25-30 feet thick in producing wells.
- 5. Drilling results thus far indicate that wells with less than 20' of gross sand thickness will not produce commercial gas quantities. The proposed location is expected to encounter 25' of "Singer" Sand.
- 6. Because of the low permeability of the Middle Morrow Sands, individual wells are expected to drain, on average, less than 160 acres.

NOW, on this <u>8th</u> day of June, 1965, the Commission, a quorum being present, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

#### FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That the applicants, Harvey E. Yates and Yates Drilling Company, seek the creation of a new gas pool for Morrow production in Eddy County, New Mexico, and the promulgation of special rules and regulations, including a provision for 640-acre spacing units.

Range 26 East, and all of Sections 7 and 18, Township 20 South, Range 27 East, NMPM, Eddy County, New Mexico.

(4) That in order to prevent the economic loss caused by the drilling of unnecessary wells, to avoid the augmentation of risk arising from the drilling of an excessive number of wells, to prevent reduced recovery which might result from the drilling of too few wells, and to otherwise prevent waste and protect correlative rights, temporary special rules and regulations providing for 640-acre spacing units should be promulgated for the McMillan-Morrow Gas Pool.

(5) That the temporary special rules and regulations should provide for limited well locations in order to assure orderly development of the pool and protect correlative rights.

(6) That special rules and regulations should be established for a temporary period to expire one year from the date that a pipeline connection is first obtained for a well in the pool; that during this temporary period all operators in the subject pool should gather all available information relative to drainage and recoverable reserves.

(7) That this case should be reopened at an examiner hearing one year from the date that a pipeline connection is first obtained for a well in the McMillan-Morrow Gas Pool, at which time the operators in the subject pool should appear and show cause why the McMillan-Morrow Gas Pool should not be developed on 320-acre spacing units.

(2) That temporary Special Rules and Regulations for the McMillan-Morrow Gas Pool are hereby promulgated as follows:

# SPECIAL RULES AND REGULATIONS FOR THE MCMILLAN-MORROW GAS POOL

<u>RULE 1</u>. Each well completed or recompleted in the McMillan-Morrow Gas Pool or in the Morrow formation within one mile thereof, and not nearer to or within the limits of another designated Morrow gas pool, shall be spaced, drilled, operated, and produced in accordance with the Special Rules and Regulations hereinafter set forth.

<u>RULE 2</u>. Each well shall be located on a standard unit containing 640 acres, more or less, consisting of a governmental section.

RULE 3. The Secretary-Director of the Commission may grant an exception to the requirements of Rule 2 without notice and hearing when an application has been filed for a non-standard unit and the unorthodox size or shape of the unit is necessitated by a variation in the legal subdivision of the United States Public Lands Survey, or the following facts exist and the following provisions are complied with:

- (a) The non-standard unit consists of quarterquarter sections or lots that are contiguous by a common bordering side.
- (b) The non-standard unit lies wholly within a governmental section and contains less acreage than a standard unit.
- (c) The applicant presents written consent in the form of waivers from all offset operators and from all operators owning interests in the section in which the non-standard unit is situated and which acreage is not included in said non-standard unit.
- (d) In lieu of paragraph (c) of this rule, the applicant may furnish proof of the fact that all of the aforesaid operators were notified by registered or certified mail of his intent

> to form such non-standard unit. The Secretary-Director may approve the application if no such operator has entered an objection to the formation of such non-standard unit within 30 days after the Secretary-Director has received the application.

RULE 4. Each well shall be located no nearer than 1650 feet to the outer boundary of the section and no nearer than 330 feet to any governmental quarter-quarter section line.

<u>RULE 5.</u> The Secretary-Director may grant an exception to the requirements of Rule 4 without notice and hearing when an application has been filed for an unorthodox location necessitated by topographical conditions or the recompletion of a well previously drilled to another horizon. All operators offsetting the proposed location shall be notified of the application by registered or certified mail, and the application shall state that such notice has been furnished. The Secretary-Director may approve the application upon receipt of written waivers from all operators offsetting the proposed location or if no objection to the unorthodox location has been entered within 20 days after the Secretary-Director has received the application.

#### IT IS FURTHER ORDERED:

(2) The applicant, Pogo Producing Company ("Pogo"), seeks to amend the special pool rules for the McMillan-Morrow Gas Pool, Eddy County, New Mexico, to provide:

- (a) the option to drill a well on each quarter section within a standard 640-acre gas spacing and proration unit; and
- (b) well setback requirements such that wells shall be located no closer than 660 feet to a quarter section line nor closer than 10 feet to any quarter-quarter section line or subdivision inner boundary.

(3) In the alternative, the applicant seeks approval to drill its Davis "18" Well No. 1 at an unorthodox gas well location for the McMillan-Morrow Gas Pool 660 feet from the North and West lines (Unit D) of Section 18, Township 20 South, Range 27 East, NMPM, Eddy County, New Mexico.

(4) Harvey E. Yates Company, an operator within Section 7, Township 20 South, Range 27 East, NMPM, appeared at the hearing through legal counsel.

(5) The "Special Rules and Regulations for the McMillan-Morrow Gas Pool" as established by Division Order No. R-2917, as amended, dated June 8, 1965, currently require standard 640-acre gas spacing and proration units with wells to be located no closer than 1650 feet to the outer boundary of the section nor closer than 330 feet to any governmental quarter-quarter section line or subdivision inner boundary. In addition, the pool rules do not currently provide the option of drilling more than one well on a standard gas proration unit.

(7) By Order No. R-5829 issued in Case No. 6337 on October 6, 1978, the Division, upon application of Mark D. Wilson, limited the area subject to the "Special Rules and Regulations for the McMillan-Morrow Gas Pool" to a five section area comprising Sections 13 and 24, Township 20 South, Range 26 East, and Sections 7, 18 and 19, Township 20 South, Range 27 East.

(8) There are currently three active producing wells within the McMillan-Morrow Gas Pool, described as follows:

- (a) the Yates Drilling Company Pecos River Deep Unit Well No. 3 located 1980 feet from the North line and 660 feet from the East line (Unit H) of Section 13;
- (b) the Atasca Resources, Inc. State "19" Com Well No. 1 located 1650 feet from the North and West lines (Unit F) of Section 19; and
- (c) the newly drilled Pogo Davis "7" Well No. 1 located 660 feet from the South and West lines (Unit M) of Section 7.
- (9) The applicant presented geologic evidence that demonstrates:
  - (a) the "Singer" sand within the Middle Morrow section is the predominant producing interval within the McMillan-Morrow Gas Pool;
  - (b) the "Singer" sand traverses the McMillan-Morrow Gas Pool in a north-south direction and varies in thickness from 0-40 feet; and
  - (c) the approximate gas-water contact within the "Singer" reservoir occurs at a depth of approximately 7,100 feet. The majority of the McMillan-Morrow Gas Pool is at a structural position above the gas-water contact.
- (10) The applicant presented engineering evidence that demonstrates:
  - (a) its Davis "7" Well No. 1, which was recently drilled at an unorthodox gas well location in Section 7 (approved by Division Order No. R-11308 dated January 13, 2000) has been completed in the McMillan-Morrow Gas Pool at an initial producing rate of approximately 7.0 MMCFGPD. The well encountered a relatively high reservoir pressure of approximately 3,200 psi. Initial pressure for this gas reservoir was approximately 4,235 psi;

- (b) Section 7 has previously been tested and developed in the McMillan-Morrow Gas Pool by the: (i) Harvey E. Yates Company Hondo Singer "A" Well No. 1 located in Unit P; and (ii) Harvey E. Yates Company Singer Davis Well No. 1 located in Unit K. These wells cumulatively produced approximately 161 MMCFG from the Morrow formation;
- (c) the drainage areas for the three existing producing wells are as follows:

| Well Name                   | Drainage Area |
|-----------------------------|---------------|
| Pecos River Deep Unit No. 3 | 72 acres      |
| State "19" Com No. 1        | 234 acres     |
| Davis "7" No. 1             | 90 acres; and |

(d) the overall average drainage area for all wells that have produced from the McMillan-Morrow Gas Pool is approximately 144 acres.

(11) A portion of the McMillan-Morrow Gas Pool comprising the SE/4 of Section 23 and the N/2 of Section 26, Township 20 South, Range 26 East, NMPM, is governed by Division Rule 104.C. which requires standard 320-acre gas spacing and proration units with wells to be located no closer than 660 feet to the outer boundary of the quarter section and no closer than 10 feet to any quarter-quarter section line or subdivision inner boundary. In addition, Rule 104.C. also provides the option to drill a second well on a standard 320-acre proration unit within the quarter section not containing the initial well.

(12) The geologic and engineering evidence presented demonstrates that approval of infill drilling within the McMillan-Morrow Gas Pool will provide the operators in the pool the opportunity to recover additional gas reserves, which may otherwise not be recovered by the existing wells, thereby preventing waste.

(13) The applicant's proposal to allow up to four wells per section is supported by its geologic and engineering evidence, and is consistent with current Division rules governing Morrow gas development in Southeast New Mexico. (14) The proposed well setback requirements will allow for greater flexibility in locating infill gas wells.

(15) The applicant notified all operators and interest owners within the area affected by this application, as described in Finding No. (7). No operator or interest owner appeared at the hearing in opposition to the application.

(16) Approval of the application is in the best interest of conservation, prevention of waste and protection of correlative rights.

# IT IS THEREFORE ORDERED THAT:

(1) The application of Pogo Producing Company to amend the "Special Rules and Regulations for the McMillan-Morrow Gas Pool," located in all or portions of Sections 13, 23, 24 and 26, Township 20 South, Range 26 East, and Sections 7, 18 and 19, Township 20 South, Range 27 East, NMPM, Eddy County, New Mexico, is hereby approved.

(2) The "Special Rules and Regulations for the McMillan-Morrow Gas Pool," are hereby amended to read in their entirety as follows:

# SPECIAL RULES AND REGULATIONS FOR THE McMILLAN-MORROW GAS POOL

**RULE 1**. Each well completed or recompleted in the McMillan-Morrow Gas Pool within Sections 13 and 24, Township 20 South, Range 26 East, and Sections 7, 18 and 19, Township 20 South, Range 27 East, NMPM, shall be spaced, drilled, operated and produced in accordance with the special rules and regulations set forth herein.

**RULE 2.** Each well shall be located on a standard unit containing 640 acres, more or less, consisting of a governmental section, provided, however, up to four wells may be drilled on a standard 640-acre proration unit. Each infill well shall be drilled in a quarter section that does not contain a well.

**RULE 3.** The Director may grant an exception to Rule (2) for non-standard spacing units after notice and opportunity for hearing when an application has been filed and the unorthodox size or shape is necessitated by a variation in the legal subdivision of the U.S. Public Land Survey or the following facts exist:

- i) the non-standard spacing unit consists of quarterquarter sections or lots joined by a common side; and
- ii) the non-standard unit lies wholly within a single governmental section.

Applications for administrative approval of non-standard spacing units shall be filed in accordance with the procedure set forth in Division Rule 104.D.(2).

<u>**RULE 4.**</u> Each initial and infill well shall be located no closer than 660 feet to the outer boundary of the quarter section on which the well is located and no closer than 10 feet to any quarter-quarter section line or subdivision inner boundary.

<u>**RULE 5.**</u> The Director may grant an exception to the requirements of Rule (4) after notice and opportunity for hearing when the exception is necessary to prevent waste and protect correlative rights.

Applications for administrative approval of unorthodox well locations shall be filed in accordance with the procedure set forth in Division Rule 104.F.

(3) Jurisdiction is hereby retained for the entry of such further orders as the Division may deem necessary.

# APPLICATION OF POGO PRODUCING COMPANY FOR A NON-STANDARD GAS SPACING AND PRORATION UNIT AND AN UNORTHODOX GAS WELL LOCATION, EDDY COUNTY, NEW MEXICO.

### **ORDER OF THE DIVISION**

#### **BY THE DIVISION:**

This case came on for hearing at 8:15 a.m. on December 16, 1999, at Santa Fe, New Mexico, before Examiner David R. Catanach.

NOW, on this 1344 day of January, 2000, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner,

### FINDS THAT:

(1) Due public notice has been given and the Division has jurisdiction of this case and its subject matter.

(2) The applicant, Pogo Producing Company, seeks an exception to the well location and spacing requirements provided within the "Special Rules and Regulations for the McMillan-Morrow Gas Pool," set forth in Division Order No. R-2917, as amended; for: (i) the formation of a non-standard 318.82-acre gas spacing and proration unit comprising Lots 3 and 4, the E/2 SW/4 and the SE/4 (S/2 equivalent) of Section 7, Township 20 South, Range 27 East, NMPM, Eddy County, New Mexico, and (ii) the dedication of this unit to its proposed Davis "7" Well No. 1 to be drilled at an unorthodox gas well location 660 feet from the South and West lines (Lot 4/Unit M) of Section 7.

(3) The "Special Rules and Regulations for the McMillan-Morrow Gas Pool" currently require standard 640-acre gas spacing and proration units with wells to be located no closer than 1650 feet to the outer boundary of the section and no closer than 330 feet to any quarter-quarter section line or subdivision inner boundary.

(4) The McMillan-Morrow Gas Pool currently comprises the following described area:

(5) By Order No. R-5829 issued in Case No. 6337 on October 6, 1978, theDivision, upon application of Mark D. Wilson, limited the area subject to the *"Special Rules and Regulations for the McMillan-Morrow Gas Pool"* to a five-section area comprising Sections 13 and 24, Township 20 South, Range 26 East, and Sections 7, 18 and 19, Township 20 South, Range 27 East.

- (6) The applicant presented geologic evidence indicating that:
  - (a) the primary target within the proposed Davis "7" Well No. 1 is the "Singer" sand within the Morrow formation;
  - (b) based upon the performance of other wells in the pool, the applicant estimates that the Davis "7" Well No. 1 needs to encounter at least 30 feet of gross "Singer" sand in order to produce commercial quantities of gas from the Morrow formation;
  - (c) the "Singer" sand traverses Section 7 in a northwest to southeast direction and is present within the entire SW/4 and in portions of the SE/4 and NW/4 of Section 7;
  - (d) the area of greatest "Singer" sand thickness (>40 feet) occurs within the SW/4 SW/4 of Section 7;

- (e) the proposed unorthodox gas well location is necessary in order to encounter the "Singer" sand in the area of greatest sand thickness within the SW/4 of Section 7; and
- (f) due to the limited extent of the "Singer" sand within the N/2 of Section 7, this area should not contribute production to the Davis "7" Well No. 1.
- (7) The applicant presented engineering evidence and testimony indicating that:
  - (a) the McMillan-Morrow Gas Pool has previously been tested in Section 7 by the (i) Harvey E. Yates Company Hondo Singer "A" Well No. 1 located in Unit P; and (ii) Harvey E. Yates Company Singer Davis Well No. 1 located in Unit K;
  - (b) the Singer "A" Well No. 1 was completed in the Morrow formation in 1965 and IP'd at a rate of approximately 306 MCFGD. The well cumulatively produced 34 MMCFG from the McMillan-Morrow Gas Pool prior to being plugged and abandoned;
  - (c) the Singer Davis Well No. 1 was completed in the Morrow formation in 1976 and IP'd at a rate of approximately 2.9 MMCFGD. The well cumulatively produced 127 MMCFG from the McMillan-Morrow Gas Pool prior to being plugged and abandoned;
  - (d) the drainage areas for wells within the McMillan-Morrow Gas Pool varies considerably and is generally less than 220 acres; and
  - (e) there are currently only two wells producing from the McMillan-Morrow Gas Pool, the Atasca Resources Inc. State "19" Com Well No. 1, located in Unit F of Section 19, Township 20 South, Range 27 East, and the Yates Drilling Company Pecos River Deep Unit Well No. 3, located in Unit H of Section 13, Township 20 South, Range 26 East.

(8) The applicant testified it provided notice of its proposed non-standard gas proration unit and unorthodox gas well location to all working, royalty and overriding royalty interest owners within the N/2 of Section 7, Township 20 South, Range 27 East, and the E/2 and SW/4 of Section 12, Township 20 South, Range 26 East.

Notice of this application was also provided to Yates Drilling Company, (9) the operator of the Pecos River Deep Unit Well No. 3 in Section 13.

(10)The remaining affected acreage is located to the south in Section 18 and is currently owned by the applicant.

No offset operator and/or interest owner appeared at the hearing in (11)opposition to the application.

(12)Approval of the proposed non-standard gas proration unit and unorthodox gas well location will provide the applicant the opportunity to recover the remaining gas reserves in the McMillan-Morrow Gas Pool within the S/2 of Section 7, thereby preventing waste, and will not violate correlative rights.

# **IT IS THEREFORE ORDERED THAT:**

The applicant, Pogo Producing Company, is hereby granted an exception (1)to the well location and spacing requirements provided within the "Special Rules and Regulations for the McMillan-Morrow Gas Pool" for (i) the formation of a non-standard 318.82-acre gas spacing and proration unit comprising Lots 3 and 4, the E/2 SW/4 and the SE/4 (S/2 equivalent) of Section 7, Township 20 South, Range 27 East, NMPM, Eddy County, New Mexico, and (ii) the dedication of this unit to its Davis "7" Well No. 1 to be drilled at an unorthodox gas well location 660 feet from the South and West lines (Lot 4/Unit M) of Section 7.

Jurisdiction is hereby retained for the entry of such further orders as the (2)Division may deem necessary.
