

Gentlemen:

Reference is made to your application for approval of a 160-acre non-standard gas proration unit in the Jalmat Gas Pool consisting of the following acreage:

Township 25 South, Range 37 East
SW/4 of Section 4

It is understood that this unit is to be ascribed to your Wells Federal Well No. 3, located 1980 feet from the South line and 1980 feet from the West line and in the NE/4 SW/4 of Section 4, Township 25 South, Range 37 East, NMPM, Lea County, New Mexico.

By authority granted me under provisions of Rule 5, Section (b)-6 of the Special Rules and Regulations for the Jalmat Gas Pool, as set forth in Order R-520, you are hereby authorized to operate the above described acreage as a non-standard gas proration unit, with allowable to be assigned thereto in accordance with Rule 12 of the pool rules, based upon the unit size of 160 acres after submission of proof of communitization to both the Santa Fe and Hobbs Office.
