Gentlemen:

On November 25, 1957, the Oil Conservation Commission of New Mexico issued Administrative Order NSP-401 which established a non-standard gas proration unit in the Justis Gas Pool comprising the following described acreage:

TOWNSHIP 25 SOUTH, RANGE 37 EAST, NMPM Section 24: SE/4 NW/4, NE/4, NE/4 SW/4, and N/2 SE/4

all in Lea County, New Mexico.

At the time the application for the above-described non-standard gas proration unit was pending, Tidewater Oil Company made representations to this Commission that it was actively negotiating with the other operators in Section 24 to form two standard proration units comprising the N/2 and S/2 of said Section and that it was the intention of Tidewater Oil Company to rededicate the acreage in Section 24 as soon as the acreage therein could be communitized. It was further stated by Tidewater Oil Company that its application for the subject non-standard unit was being made only because of the unavoidable delays involved completing such a communitization agreement.

In reliance on the above-referenced statements, the Commission entered NSP-401 with the understanding that it would remain in force only until such time as communitization of Section 24 could be accomplished.

The Commission was recently advised by the Legal Department of your Tulsa office that due to budget reasons Tidewater Oil Company is no longer actively attempting communitization of Section 24. In view of this fact, the Commission feels that NSP-401 should be cancelled effective June 1, 1958.
