Gentlemen:

Sinclair Oil & Gas Company makes this application for an Administrative Order under Order No. R-610 which will establish an 80 acre Nonstandard Gas Proration Unit in the Blinebry Gas Pool to be assigned to Sinclair's A. M. York "A" Well No. 1. (See attached ownership plat).

In this connection Sinclair wishes to state:

1. Sinclair is the operator of the A. M. York "A" Well No. 1 which is located 330 feet from the East line and 2310 feet from the North line of Section 20, T-21-S, R-37-E, Lea County, New Mexico. This well was completed in the Drinkard formation on November 16, 1947, which was prior to the effective date of said Order No. R-610. Sinclair is currently attempting to dually complete this well in the Drinkard and Blinebry formations.
2. The proposed 80 acre nonstandard unit consists of Sinclair's A. M. York "A" and "B" leases and occupies the E/2 of the NE/4 of said Section 20. The leasehold interest is common under the entire unit.
3. The length or width of the proposed unit does not exceed 5280 feet.
4. The proposed unit consists of contiguous quarter-quarter sections and lies wholly within a single governmental section.
5. The entire proposed unit may reasonably be presumed to be productive of gas from the Blinebry Gas Pool.
6. All offset operators as defined in Order No. R-610 have been notified of this application by copy thereof via registered mail. Said operators are listed below.

Sinclair believes that the granting of this application is in the interest of conservation and the protection of correlative rights. Sinclair, therefore, requests that an Administrative Order be issued for the purpose of granting this application.

I hereby certify that the information contained in this application is true and complete to the best of my knowledge and belief.
