Gentlemen:

Humble Oil & Refining Company respectfully requests administrative approval of a 120-acre non-standard gas proration unit for the subject well in the Blinebry and Tubb Gas Pools. In support of this application, we submit the following information:

1. Humble Oil & Refining Company is the owner and operator of the New Mexico State "V" Lease located in Section 10, T-21-S, R-37-E, Lea County, New Mexico. Well No. 11 is located 2080 feet from the South and 2080 feet from the West lines of said Section 10.
2. The subject well was completed in the Hare Pool in December, 1953. In 1958 the well was plugged back and dually completed in the Tubb and Blinebry Pools.
3. A non-standard unit of 120 acres will be assigned to each zone as noted on Form C-128 previously filed with your office.
4. The acreage consists of contiguous quarter-quarter sections located wholly within a single governmental section.
5. The entire unit may reasonably be presumed to be productive of gas and the length and width does not exceed 2640 feet.
6. All offset operators were notified on December 30, 1958 by Certified Mail of Humble's application.


