

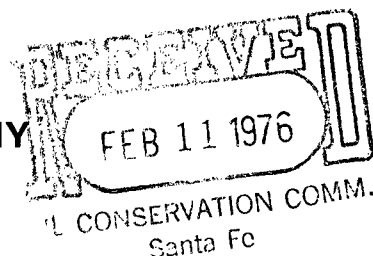

Gentlemen:

We respectfully request administrative action, subject to your receipt of waivers of objection or to the 20-day waiver waiting period, on our application for a non-standard 80-acre proration unit to be dedicated to the captioned well. This well is located in Unit L, 660 feet FW and 2050 feet FS Lines, Section 24, T-22-S, R-37-E, with the 80-acre unit designated consisting of contiguous governmental quarter-quarter sections further described as the W/2 SW/4 of the said Section.

This well formerly was completed in the Tubb pool which has been temporarily abandoned, and has now been recompleted in the Blinebry reservoir. It is a replacement for Well No. 1 in which the Blinebry zone has been temporarily abandoned. Further, NSP-490 applied to this non-standard unit at the time it was dedicated to Well No. 1.

By certified mail copy hereof, offset operators are notified of this application with the request that their waivers be mailed direct to your office with a copy to us for our files.

This request for administrative action is made under provisions of Order Number R-1670-N and as exceptions to its rules 5(A) and 5(C)—3.

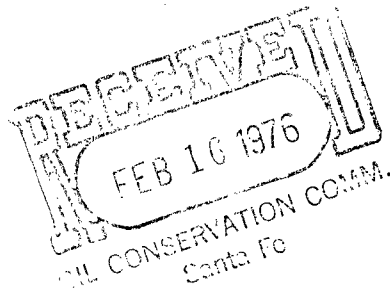
