Comes now Markham, Cone & Redfern, independent producers with offices in Lubbock, Texas, who respectfully request administrative approval of a non-standard gas proration unit as an exception to Rule 5 (A) of Order No. R-610 relating to the Blinebry Gas Pool, and in support thereof state:

1. Applicants are the owners of the oil and gas operating rights under all of the SW/4 of Section 14, T-21-S, R-37-E, NMPM, Lea County, New Mexico, said lease comprising 120 acres, more or less, and being known as the Markham, Cone & Redfern Eubanks lease.

2. Applicants completed their Eubanks Well No. 1 June 13, 1952 as a dual producer from the Blinebry Gas and the Drinkard Pools as authorized by Order No. R-137, at a location 660 feet from the South line and 660 feet from the West line of the said Section 14. The Blinebry Gas perforations in Eubanks Well No. 1 are contained in the interval 5510 to 5655 ( subsea datum minus 2093 to minus 2238) feet; and, the Drinkard produces from the open-hole interval 6512 to 6617 feet. Over the producing life of the Blinebry Gas zone in Eubanks Well No. 1, the gas and liquid characteristics have been consistently within the limitations set by Rule 18, Order No. R-610-B.

3. Applicants completed their Eubanks Well No. 4 January 27, 1960 as a dual producer from the Blinebry Oil and the Drinkard Pools, as authorized by Order No. DC-878, at a location 660 fest from the South line and 1980 feet from the West line of the said Section 14. The Blinebry Oil perforations in Eubanks Well No. 4 are contained in the interval 5683 to 5872 (subsea datum minus 2266 to minus 2365) feet; and, the Drinkard perforations are contained in the interval 6530 to 6645 feet. On initial potential test January 25, 1960, the Blinebry Oil zone in Eubanks Well No. 4 flowed 270 barrels of oil in 24 hours, liquid gravity being 41 degrees API, and gas-oil ratio being 1089 oubic feet per barrel.

Page 2: Application of Markham, Cone & Redfern for a 120-Acre Non-Standard Gas Proration Unit, Blinebry Gas Pool.

4. Rule 6 of Order No. R-610 states: "Acreage dedicated to a gas well in the Blinebry Gas Pool shall not be simultaneously dedicated to an oil well in the Blinebry Oil Pool". Accordingly, Applicants respectfully request that the N/2 SW/4 and SW/4 SW/4 of the said Section 14, being 120 acres more or less, be designated as a non-standard gas provation unit in the Blinebry Gas Pool and assigned to the Blinebry Gas zone in Markham, Cone & Redfern Eubanks Well No. 1.

5. Creation of the proposed non-standard gas proration unit and the assignment of the acreage therein to Markham, Cone & Redfern Eubanks Well No. 1 is in the interest of conservation and will protect correlative rights.

6. A plat showing the said Eubanks lease and well, the acreage to be dedicated, and offset ownership is attached hereto.
