Dear Sir:

Olsen Oils, Incorporated requests approval of a non-standard gas proration unit of 80 acres consisting of the E/2 NW/4 of Section 30, T 25S, R 37E, Lea County, New Mexico, on which is located the Winningham #1.

Olsen Oils, Incorporated warrants that the non-standard gas proration unit consists of contiguous quarter-quarter sections lying wholly within a single governmental section and further warrants that the non-standard gas proration unit is productive of gas and that the length or width of the non-standard gas proration unit does not exceed 5280 feet.

The above unit is decreased by 80 acres due to the fact that Winningham #1 will not make its current assigned allowable and further rework is deemed uneconomical.

By copy of this letter all offset operators within Section 30, T 25S, R 37E and within 1500 feet of subject well are notified of the company's request for a non-standard gas proration unit.


