Under the provisions of Commission Order No. R-520, Rule 5 (b) Special Rules and Regulations for the Jalmat Gas Pool, delegating the Secretary of the Commission authority to grant exceptions to the requirements of Rule 5 (a) without Notice and Hearing for a Non-Standard Proration Unit, Weier Drilling Company hereby makes application for a Non-Standard Proration Unit for the subject well.

In support of the application, we present the following:

1. Original and two copies of the application with plat showing the proposed unit of 160 contiguous acres, consisting of the SW/4 of Section 28, Township 37 East, Range 24 South, Lea County, New Mexico.
2. The entire proposed non-standard proration unit may reasonably be presumed to be productive of gas and lies wholly within a single governmental section. The length or width of the unit does not exceed 5280 feet.
3. All owners having an interest in the section in which the proposed unit is situated and which acreage is not included in said unit and all operators owning interest within 1500 feet of the unit well have been notified of the application by registered mail.

The 160 acres consisting of the SW/4 of Section 28 is presently dedicated as follows:

Woolworth No. 3, Unit M, located 990' from the south line and 990' from the west line of Section 28, has 80 acres consisting of the S/2 of the SW/4 of Section 28, Township 37 East, Range 24 South.

Woolworth No. 4, Unit L, located 1650' from the south line and 990' from the west line of Section 28 has 80 acres consisting of the N/2 of the SW/4 of Section 28, Township 37 East, Range 24 South.

It is proposed to shut in Woolworth No. 4, Unit L, and dedicate the 160 acres as shown to Well No. 3, Unit M.


