Gentlemen:

Texaco Inc. respectfully requests administrative approval of a non-standard gas proration unit to be dedicated to the Texaco Inc. A. H. Blinebry NCT-1 Well No. 16 located in Unit J, Section 33, T-22-S, R-38-E, Lea County, New Mexico. Two existing conditions necessitate a non-standard proration unit for this well. Firstly, only three quarter-quarter governmental sections are available for dedication to Well No. 16. Secondly, included in Texaco's A. H. Blinebry NCT-1 Lease, in addition to the three quarter-quarter governmental sections, is a tract consisting of 6.18 acres lying alongside and east of the NE/4 of the SE/4 of Section 33, being a narrow strip lying between Section 33 and the New Mexico-Texas north-south state boundary. The attached copy of Form C-128 serves to illustrate these two conditions. It may also be noted that the maximum width of this proration unit will exceed the limit of 2640' by 203.94'. It is, therefore, requested that your approval of an exception to Rule 5 (B) of the General Rules and Regulations for Southeastern New Mexico adopted in Order No. R-1670 for the prorated gas pools of Southeastern New Mexico on May 20, 1960, will include approval of:

1. A unit consisting of less than 160 acres,
2. A unit including 6.18 acres outside of the one-quarter section in which the well is located but contiguous thereto, and
3. A maximum width of the proration unit of 2843.94'.

This request is as provided by Rule 5 (C) in that the following provisions are complied with:

1. The proposed non-standard proration unit consists of less than a standard proration unit of 160 acres.
2. The unit consists of contiguous tracts.
3. The unit lies wholly within a single governmental quarter section with the exception of an adjoining 6.18 acres that lies between Section 33 and the New Mexico-Texas state boundary line.
4. All acreage may reasonably be presumed to be productive.
5. Exception is requested for the maximum dimension of 2640'.
6. Letters requesting waivers, with a copy of this letter, have been mailed to (a) all operators outside the unit but within the single one-quarter section, and (b) all operators within 1500' of the well to which this non-standard proration unit is to be dedicated.

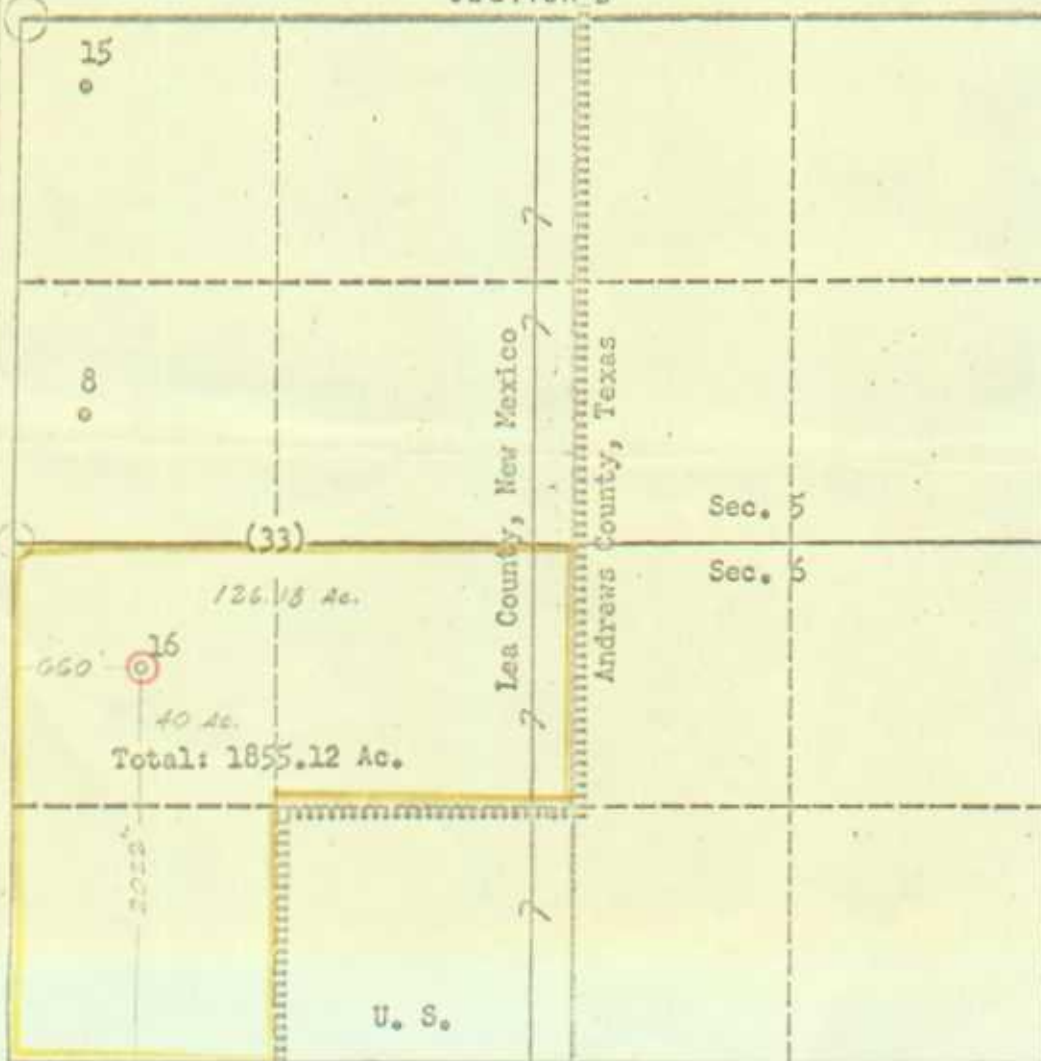
