Re: Application of Amerada Hess Corporation for administrative approval of a 160 acre non-standard gas proration unit in the Blinebry completion of its State D "A" well No.4, located in Unit I, Sec.16, T-21-S, R-37-E, Lea County, New Mexico.

Gentlemen:

Amerada Hess Corporation requests that a 160 acre non-standard gas proration unit consisting of the N/2-S/2, Sec.16, T-21-S, R-37-E, Lea County, New Mexico be reassigned to the State D "A" well No.4.

The subject well was completed in the Blinebry zone and a 160 acre non-standard gas proration unit consisting of the N/2-S/2,Sec.16, T-21-S, R-37-E, was assigned effective January 1, 1954. Application was made and approved by Commission Order NSP-609 for the establishment of an 80 acre non-standard gas proration unit, consisting of the N/2-SE/4, Sec.16, T-21-S, R-37-E, for the subject well effective August 6, 1962. This well was temporarily abandoned January 1, 1965; at which time well No. 5 was completed a Blinebry oil well. Well No. 5 has been temporarily abandoned.

The following operators within Section 16, and with properties closer than 1500' from subject well have been furnished a copy of this application.
