Continental Oil Company Application for a 160-Acre NSP Unit - State E Well No. 8, Section 17, T-22S, R-36E, Lea County, New Mexico

Continental Oil Company respectfully requests Administrative Approval under the provisions of Rule 5 (b) of the Special Rules and Regulations for the Jalmat Gas Pool of Order No. R-1670 for approval of a 160-acre non-standard gas proration unit for its State E Well No. 8, located 1980' from the north line and 1980' from the west line of Section 17, T-22S, R-36E, Lea County, New Mexico in the Jalmat Gas Pool.

The unit is proposed to consist of the E/2 W/2 of Section 17, T-22S, R-36E. In support of this request we should like to point out that the proposed unit conforms with the requirements of Rule 5 (b) in all respects as follows:

- Said unit consists of contiguous quarter-quarter sections (and/or lots).
- Said unit lies wholly within a single governmental section.
- 3. The entire proposed unit may be reasonably presumed to be productive of gas.
- 4. The length or width of said unit does not exceed 5,280 feet.
- 5. Copies of this application have been furnished by certified mail to all offset operators and all operators within 1,500 feet of said well.
