


Dear Sir:

The subject well was reclassified to a gas well effective January 1, 1972 in order to comply with provisions of Order No. 1670 pertaining to the Blinebry gas pool. Texas Pacific Oil Co., Inc. requests that a 40 acre non-standard proration unit be assigned this well located 1980' FSL and 1980' FEL of Section 26. This 40 acres being the NW/4 of SE/4 of Sec. 26, T-21-S; R-37-E, Lea County, New Mexico.

In October 1966, administrative Order NSP-769 was approved for 80 acres non-standard gas proration unit but since this time S. E. Cone Well No. 4 was drilled and assigned 40 acres oil allowable. We request administrative approval of this 40 acres be assigned to our S. E. Cone Well No. 1 - Blinebry Gas. A packer leakage test was taken April 27, 1971 with approved results.

All offset operators have been notified by registered mail.
