Dear Ms. Anderson:

Reference is made to the following: (i) your application dated April 26, 1999; and (ii) the records of the New Mexico Oil Conservation Division ("Division") in Santa Fe: all concerning Apache Corporation's request for a 40-acre non-standard gas spacing and proration unit ("GPU") consisting of the following acreage in the Blinebry Oil and Gas Pool:

LEA COUNTY, NEW MEXICO <u>TOWNSHIP 21 SOUTH, RANGE 37 EAST, NMPM</u> Irregular Section 4: Lot 15.

It is our understanding that this unit is to be dedicated to Apache Corporation's existing Gulf Hill Well No. 3 (API No. 30-025-06403), located at a standard gas well location 3300 feet from the South line and 1980 feet from the East line (Unit O) of Section 4.

By authority granted me under the provisions of **Rule 2(d)** of the "General Rules for the Prorated Gas Pools of New Mexico/Special Rules and Regulations for the Blinebry Oil and Gas Pool," as promulgated by Division Order No. R-8170, as amended, the above-described 40-acre GPU is hereby approved. Also, you are hereby permitted to produce the allowable assigned the subject GPU, in accordance with Rule 5 of the pool rules based upon a unit size of 40 acres.

It is further ordered that Division Administrative Order NSP-892, dated October 25, 1972, which order established an 80-acre non-standard Blinebry gas spacing and proration unit comprising Lots 14 and 15 of Section 4 and was dedicated to this well from 1972 to 1980 when it was operated by Summit Energy, Inc. as a Blinebry gas well, shall be placed in abeyance until further notice.
