Continental Oil Company's Application for a 240-acre NSP Unit - SEMU Eumont
No. 66 - Section 14, T-20S, R-37E, Lea County, New Mexico

Continental Oil Company respectfully requests administrative approval under the provisions of Rule 5 (b) of the Special Rules and Regulations for the Eumont Gas Pool of Order No. R-1670 for approval of a 240-acre Non-standard Gas Proration Unit for its SEMU Eumont No. 66 located 1980' FSL and 660' FWL of Section 14, T-20S, R-37E, Lea County, New Mexico in the Eumont Gas Pool. The Unit is proposed to consist of SW/4 and the W/2 of the SE/4 of Section 14, T-20S, R-37E.

SEMU Eumont No. 66 currently has a 640-acre Non-Standard Gas Proration Unit assigned, as approved by Order No. R-3833. We wish to have this order cancelled, in so far as it refers to well No. 66 in paragraph 1 (d) of the Order dated September 8, 1969.

In support of this request, we would like to point out that the proposed unit conforms with the requirements of Rule 5 (b) in all respects as follows:

- 1) Said Unit consists of contiguous quarter/quarter sections and/or lots
- 2) Said unit lies wholly within a single governmental section
- 3) The entire proposed unit may be reasonably presumed to be productive of gas
- 4) The length or width of said unit does not exceed 5280'
- 5) Copies of this application have been furnished by certified mail to all offset operators and all operators within section 14.



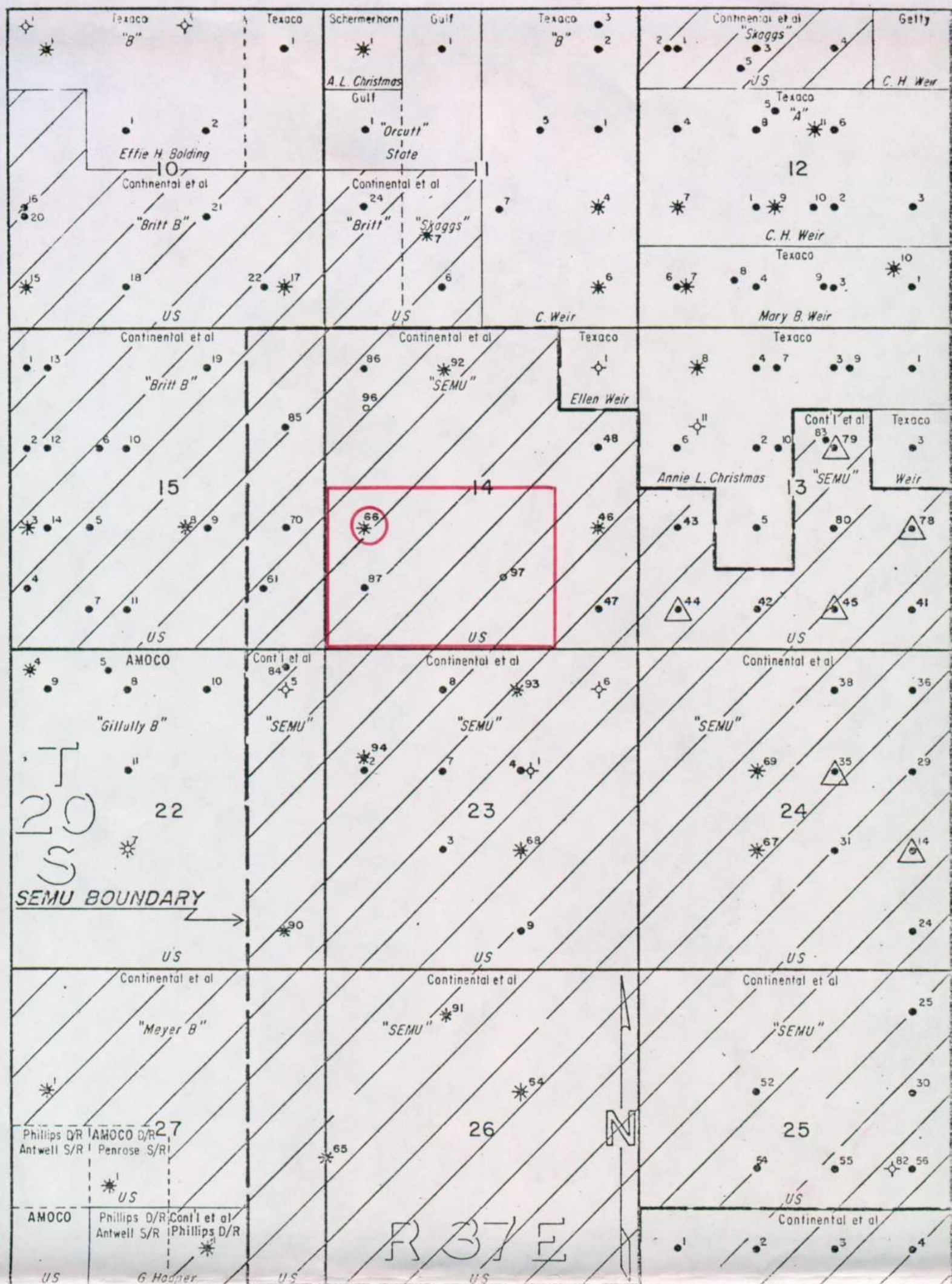

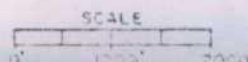
